AN ACT

To amend an act approved the twelfth day of May one thousand nine hundred eleven (Pamphlet Laws three hundred one) entitled "An act to ascertain and appoint the fees to be received by the several prothonotaries of the courts of common pleas of the Commonwealth in counties having a population of over two hundred thousand and under one million and to provide the time of paying the same" as amended

1 Section 1 *Be it enacted by the Senate and House of Repre-*
2 *sentatives of the Commonwealth of Pennsylvania in General Assembly*
3 *met and it is hereby enacted by the authority of the same That*
4 section one of an act approved the twelfth day of May
5 one thousand nine hundred eleven (Pamphlet Laws three
6 hundred one) entitled "An act to ascertain and appoint
7 the fees to be received by the several prothonotaries of
8 the courts of common pleas of the Commonwealth in
9 counties having a population of over two hundred thou-

1 sand one under one million and to provide the time of
2 paying the same" which as amended by the act approved
3 the second day of April one thousand nine hundred
4 thirteen (Pamphlet Laws thirty-seven) entitled "An act to
5 amend an act approved the twelfth day of May one
6 thousand nine hundred and eleven (Pamphlet Laws three
7 hundred one) entitled 'An act to ascertain and appoint
8 the fees to be received by the several prothonotaries of
9 the courts of common pleas of the Commonwealth in
10 counties having a population of over two hundred thou-
11 sand and under one million and to provide the time of
12 paying the same' and the act approved the twenty-third
13 day of May one thousand nine hundred and thirteen
14 (Pamphlet Laws three hundred fifteen) entitled "An act
15 to amend section one of an act entitled 'An act to
16 ascertain and appoint the fees to be received by the
17 several prothonotaries of the courts of common pleas of
18 the Commonwealth in counties having a population of over
19 two hundred thousand and under one million and to pro-
20 vide the time of paying the same' approved the twelfth
21 day of May one thousand nine hundred eleven by chang-
22 ing the minimum population of counties to which the
23 said act shall apply from two hundred thousand to one
24 hundred fifty thousand" which reads as follows

25 "Section 1 Be it enacted by the Senate and House
26 of Representatives of the Commonwealth of Pennsylvania in
27 General Assembly met and it is hereby enacted by the
28 authority of the same That the fees to be received by
29 the several prothonotaries of the courts of common pleas
