AN ACT

Amending the act of June 22 1931 (P L 594) entitled "An act establishing certain township roads as State highways authorizing their construction maintenance and improvement under certain conditions and restrictions limiting the obligation of the Commonwealth in the construction of certain structures located on such highways conferring certain powers upon the Department of Highways and local authorities persons associations and corporations for sharing the cost of the maintenance and construction of such highways and making an appropriation to carry out

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows

1 Section 1 The act of June 22 1931 (P L 594) entitled "An act
2 establishing certain township roads as State highways authorizing their
3 construction maintenance and improvement under certain conditions
4 and restrictions limiting the obligation of the Commonwealth in the
5 construction of certain structures located on such highways conferring

9 to carry out the provisions of said act" is amended by adding the follow-
10 ing new routes

11 Jefferson County

12 Route Beginning at the intersection of Legislative Route
13 33015 and Township Road 362 thence in a southeasterly direction over
14 Township Road 362 to its intersection with Township Road 372 a
15 distance of about 1.1 miles in Perry Township Jefferson County

1 47 Jefferson County

2 Route Beginning at the intersection of Township Road 372
3 and Township Road 362 thence in a southeasterly direction over Town-
4 ship Road 372 to its intersection with Legislative Route 33024 a distance
5 of about 1.4 miles in Perry Township Jefferson County

6 Section 2 The highways established as State highways under the
7 provisions of this act may be taken over for construction and mainte-
8 nance at any time subsequent to the final enactment of this act when
9 the same shall become effective and shall be taken over not later than
10 January 1 1962
