CHAPTER LXI.

An ACT for the better establishing and confirming the boundaries of the town and out-lots of the town of Indiana.

WHEREAS by an act of the General Assembly of this Commonwealth, passed the twenty-fifth day of March, one thousand eight hundred and five, Charles Campbell with others were appointed trustees for the county of Indiana, and authorized to lay out in town and out lots, certain land therein mentioned, and to sell the same, and were required to transmit a draught of such lots to the Secretary of the Commonwealth, to be deposited in his office. And whereas, the said trustees did proceed to lay out the lots as directed, and filed in the said office a draught of the same, agreeably to the directions of the act aforesaid. And afterwards on their proceeding to sell the said lots, they found it absolutely necessary to make considerable alterations in the plan of the said town and out-lots; agreeably to which they made out a second draught and survey, and sold the said lots agreeably thereto. And afterwards the said trustees in pursuance of an act passed the seventeenth of December, one thousand eight hundred and seven, did surrender and set over to the commissioners of Indiana county, all their powers and trust held by virtue of the first above mentioned act with the second draught of the said town and out-lots, which is found to be very imperfect, as neither the courses, distances or boundaries of the said lots on the ground can be well ascertained: Therefore,

SECTION I. *Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same,*

Commissioners of Indiana to make a resurvey of the town of Indiana and out lots, and transmit a draught of the same to the office of the secretary of state.

That the county commissioners of Indiana county are hereby authorized and empowered to employ an experienced and competent surveyor to retrace the lines of the town and out-lots, streets, lanes and alleys of the town of Indiana, and to mark the boundaries thereof, in a distinct and lasting manner, and having completed the same, it shall be their duty to file a map or draught of the said town and out-lots as actually laid out in the Secretary's office of this commonwealth, and to have a like draught recorded in the office for recording of deeds in

the county of Indiana, and one other draught or plot of said town to be filed in the commissioners office of said county.

SECT. II. *And be it further enacted by the authority aforesaid,* That all expences incurred under the provisions of this act shall be paid by warrants drawn by the commissioners on the treasury of Indiana county.

CHAPTER LXII.

An ACT granting to Samuel M^cNeill an annuity for life.

WHEREAS it appears to the legislature that Samuel M^cNeill when serving as a volunteer in captain Longstreth's company, in the army of the United States, at the battle of Princeton, received a violent contusion in his leg, by which he is rendered unable to support himself by any kind of labour.

SECTION I. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same,*

That the governôr be, and he is hereby authorized to draw his warrant on the state-treasurer, in favour of Samuel M^cNeill, of Northampton county, for forty dollars, to be paid out of any unappropriated monies in the treasury, and that an annuity of forty dollars be granted to the use of Samuel M^cNeill, to be paid to George Palmer of Northampton county, his executor or executors, administrator or administrators, his or their lawful attorney, by the state-treasurer, to commence the first day of January, one thousand eight hundred and ten, which annuity shall be expended by the said George Palmer, his executor or executors, administrator or administrators, or his or their lawful attorney, in providing clothing and diet for the said Samuel M^cNeill, and it shall and is hereby made the duty of the said George Palmer, his executor or executors, administrator or administrators, his or their lawful attorney, to make an annual return to the orphans court of Northampton county, on oath or affirmation, how and in what manner he or they have executed the trust in him or them confided by this act.
