## CHAPTER CXXIII.

A supplement to an act entitled. " An act to incorporate a company for making an artificial road from Harrisburg through Lewistown and Huntingdon, to Pittsburg."

SECT. 1: DE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the duthority of the same, That for the purpose of making a turnpike road Commisover the Allegheny Mountain, from the south east side in sioners ap-Huntingdon county, in the best direction from the borough pointed. of Huntingdon to Pittsburg, to the foot of Laurel-Hill, on the west, as an important part of the great road contemplated by the act to which this is a supplement, the following persons viz. One or more of the aforesaid commissioners, shall attend and receive subscriptions from all persons of lawful age, who shall offer to subscribe in the said book, which shall be kept open for the purpose aforesaid, at least six hours in every juridical day, for he kept open the space of six days, or until the book or books, shall have subscribed therein respectively as follows, viz. SECT. II. And be it further enacted by the authority aforesaid, That when fifty persons or more, shall have subscribed one third of the shares aforesaid, the commissioners may, or when the whole number of shares aforesaid, shall be subscribed, they shall certify under their hands and seals, the names of the subscribers, and the number of shares subscribed by each, to the Governor of this commonwealth, and when the one-third of the whole number of shares shall be subscribed, it shall, and may be lawful for the Governor by letters patent under his hand, and the seal of the State, to create and erect the subscribers into one body politic, and corporate, in deed and in law, by the name, style and title of "The President, Managers and Company of the Huntingdon, Cambria and Indiana turnpike road," and by the said name, the said subscribers shall have succession, and all the privileges and franchises incident to a corporation, and shall be capable of taking and holding their said capital stock, and the increase and pro-And privile- fits thereof, and of enlarging the same, from time to time, by new subscriptions, in such manner and form as they shall think proper, if such enlargement shall be found necessary to fulfil the intent of this act, and of purchasing, taking and holding to them and their successors and assigns, and of selling, transferring and conveying in fee simple, or for any less estate,

all such lands, tenements, hereditaments and estate, real and personal, as shall be necessary to them in the prosecution of their work, and of suing and being sued, and of doing all and every other matter and thing which a corporation or body politic, may lawfully do, and generally have all the powers, authorities and privileges, and be subject to all the duties qualifications and restrictions, penalties, fines and forfeitures And restricwhich are given and granted, or imposed upon the president, tion. managers and company under the act to which this is a supplement.

SECT. III.
