page 351, &c. whereby the said William Corkadle and wife conveyed to the said Isaac Wisener, all their estate, title and interest in a lot of land situate in the township aforesaid, containing eleven acres and eighty-nine perches, be, and the same is hereby declared to be as valid in law to all intents and purposes as if the said William Corkadle had been a citizen of the United States at the time of acquiring the property aforesaid; Provided aiways, That nothing herein contained shall be construed individual rights to bar or defeat any person or persons, of any right, title or in- secured. terest which they may lawfully have, in or to the said lot or piece of land, or any part or parcel thereof.

## CHAPTER VI.

An ACT to authorize the trustees of the Methodist Episcopal Congregation in the town of Washington, to convey a certain lot of ground therein mentioned.

WHEREAS John Hoge of the town of Washington, and state of Pennsylvania, by deed dated the fifth day of February, in the year of our Lord, one thousand eight hundred and one, did convey a lot of ground numbered 194 in the plot of said town, to Thomas Lackey, Abraham Craiger, Abraham Johnston, Titus Rigby, and John Cooper, and their successors, in trust for the use of the members of the Methodist Episcopal church in the United States of America, for the purpose of having a house for Divine worship erected thereon, and the said trustees having, through mistake erected said house on lot No. 193, which still remains the property of the said John Hoge, and are desirous of exchanging the title which the members of said church, have in lot No. 194, with said John Hoge for a title to lot No. 193; Therefore,

SECT. 1. Be it enacted by the Senate and House of Representatives of the commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That James Chambers James Chambers Thomas Lackey, Abraham Johnston, James thought Episcopal Shannon, and Israel Brown, the present trustees of the Methodist Episcopal church, or their successors in office, are hereby the right of the said church in a s bers of the Methodist Episcopal church, in the United States John Hoge.

## CHAPTER VII.

An ACT to authorize the directors of the poor of Dauphin county, to sell certain real property therein mentioned.

WHERFAS it appears to the legislature, that in pursuance of two several acts of the general assembly of this commonwealth, one of which was passed on the twenty-eighth day of March, in the year of our Lord, one thousand eight hundred and six, and the other, on the fourth day of March, in the year following, a plantation or tract of land situate in Swatara township, in Dauphin county, was purchased by the directors of the poor of said county, for the purpose in the said acts mentioned, on which said tract of land there is a grist mill erected; and whereas it appears that a considerable portion of the purchase money of said tract of land is yet unpaid by the said directors, and that the rents and profits of the said mill are insufficient to discharge the interest annually accruing on the same: Therefore,

Directors of the peor of Dauphin county authorized to sell a mill and part of a plantation, &c. SECT. I. Be it enacted by the Senate and House of Representatives of the commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the directors of the poor of Dauphin county be authorized to sell, either at auction or by private sale, the mill aforesaid, together with such part of said plantation or tract of land, not to exceed twenty-five acres in the whole, and also together with such right to the use of the said stream turning the said mill as the said directors may deem necessary, to the reasonable use and enjoyment of the same, and to apply the proceeds of such sale to the payment of such part of the purchase money as yet remains unpaid.

Mode of applying the proceeds thereof.

Authorized to make a good title to the purchasers, &c. SECT. II. And be it further enacted by the authority aforesaid, That the directors be authorized and empowered to execute such deed of assurance to the purchaser or purchasers of
