CHAPTER LXXXIV.

An ACT for the relief of certain persons therein mentioned.

SECT. I. *BE it enacted by the Senate and House of Representatives of the commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the sum of fifty dollars each be paid to William Cole, Charles Westfall, Daniel Phile, James Atkinson, Charles Hong, John Knipe, Abraham Ogden and Samuel Wilkins, or their order, out of the funds heretofore appropriated for the support of government, in full for their loss of time while in prison, and expenses paid in opposing a prosecution issued against them out of the district court of the United States, in consequence of their obedience as militia to the orders of the governor issued under the act entitled, "An act relating to the claim of this commonwealth against Elizabeth Sergeant and Esther Waters, surviving executrices of David Rittenhouse, esquire, deceased," passed April second, one thousand eight hundred and three.*

William Cole and others allowed 50 dollars each for loss of time and expenses while in imprisonment.

CHAPTER LXXXV.

An ACT to compensate William Henry Kilbuck, a chief of the Delaware tribe of Indians.

WHEREAS William Henry Kilbuck, a native American, of the Delaware tribe, in the time of the revolutionary war rendered essential services to the United States, some of which were particularly advantageous to Pennsylvania; Therefore,

S. CT. I. *Be it enacted by the Senate and House of Representatives of the commonwealth of Pennsylvania, in General Assembly*

40 dollars gratuity and 40 dollars annuity granted to W. H. Kilbuck.

met, and it is hereby enacted by the authority of the same, That the treasurer of this commonwealth is hereby directed to pay to John Heckewelder, the sum of forty dollars immediately: And the further sum of forty dollars annually during the life of William Henry Kilbuck, to be by him the said John, transmitted to him the said William, clear of all charges, and that at all times within three months after the receipt thereof.

60 dollars granted to purchase three rifles for the sons of the said W. H. Kilbuck. The above sums to be paid to J. Heckewelder for the purposes aforesaid.

SECT. II. *And be it further enacted by the authority aforesaid,* That the further sum of sixty dollars is hereby appropriated to be paid by the treasurer of this commonwealth to John Heckewelder, who shall procure three rifles therefor, and shall deliver or cause to be delivered one thereof to the oldest son of William Henry Kilbuck, (to wit,) John Henry Kilbuck, one other thereof, to his second son Charles Henry Kilbuck, and the other to his youngest son Christian Gotlieb Kilbuck, which said rifles he shall present to the persons aforesaid in the name of this state.

J. Heckewelder to give bond, &c.

SECT. III. *And be it further enacted by the authority aforesaid,* That before any of the money be paid by the treasurer aforesaid to the said John Heckewelder, he shall give bond to the secretary of this commonwealth in the name of the same, with one or more sureties in one thousand dollars that he will annually produce to the auditor-general satisfactory receipts that what has been granted by this act has been received by the proper persons clear of any expense whatever.

CHAPTER LXXXVI.

An ACT to establish the boundary lines of Ontario county.

Trustees of Ontario county to mark the boundaries of said county.

SECT. I. *Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same,* That the trustees of the county of Ontario are hereby authorized and required to establish a point east of the Slippery Rocks, (so called,) at the head of Wyalusing falls in the river of Susquehanna, for the south-east corner of Ontario county; from thence a line west to the said Slippery Rocks; from thence a south-westerly course to the nearest point of Lycoming county, is hereby established as a southern boundary of the said county,
