CHAPTER LXX.

A further SUPPLEMENT to an act, entitled "An act establishing the seat of government of the commonwealth of Pennsylvania, at Harrisburgh, in the county of Dauphin."

SECT. I. *BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania in general assembly met, and it is hereby enacted by the authority of the same,* That the sum of thirteen thousand dollars be, and the same is hereby appropriated, to complete the fire-proof offices at Harrisburgh, the building of which was authorized by the sixth section of the act to which this is a supplement. § 13,000 appropriated.

SECT. II. *And be it further enacted by the authority aforesaid,* That the money hereby appropriated, or so much thereof as may be necessary, shall be paid by the treasurer of the commonwealth, on the order signed by any two of the commissioners appointed under the act aforesaid, who are hereby enjoined and required to keep regular and true accounts of all the monies they may expend in completing the offices aforesaid, and to transmit said accounts with necessary vouchers to the auditor-general, agreeably to the act aforesaid and the supplements thereto. How to be paid.

SECT. III. *And be it further enacted by the authority aforesaid,* That the secretary of the commonwealth, secretary of the land-office, surveyor-general, state treasurer, and auditor-general, be and they are hereby authorized, and it is made their duty to employ and contract with one or more carpenters, to make suitable counters, shelves, and other necessary furniture, in all the departments of the offices of government in said buildings, for the reception and safe-keeping the books and documents belonging to their respective offices, and transmit the accounts to the auditor-general, who shall draw his warrant on the treasurer of Shelves, counters, &c. to be erected.

CHAPTER LXXI.

A SUPPLEMENT to the act, entitled "An act to incorporate the Philadelphia society, for the encouragement of domestic manufactures."

SECT. I. *BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania in general assembly met, and it is hereby enacted by the authority of the same, That the act entitled, an act to incorporate the Philadelphia society, for the encouragement of domestic manufactures, passed the eleventh day of March, one thousand eight hundred and seven, be and the same is hereby extended, and continued in force for the term of twenty years, with all the powers, privileges and restrictions, contained in the original act: to which this is a supplement.*

SECT. II. *And be it further enacted by the authority aforesaid, That the said corporation shall not purchase or dispose of any goods, other than such as have been manufactured in the whole or in part within the United States.*

CHAPTER LXXII.

An ACT for the relief of Robert Love.

WHEREAS it appears to the legislature, that certificates of funded debt were issued to Robert Love, of the county of Northumberland, (now Lycoming,) numbered 4758, 4962, and 6005, and that a certificate numbered 6018, issued to John Love, his minor son; that the said certificates were lost on their way to the said Robert Love; and that they have never been redeemed by the commonwealth: Therefore,
