CHAPTER LXXVII.

A SUPPLEMENT to the act, entitled " An act authorizing the governor to incorporate a company, for making an artificial road from the bank of the river Susquebanna, opposite the borough of Harrisburgh, to Pittsburgh.

Sect. 1. BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and is is hereby enacted by the authority of the same, That Route to be as soon as the company shall have been incorporated, agreeably marked. to the provisions of this act, and the act to which this is a supplement, the president and managers of the same, shall proceed to lay down, mark, and ascertain, such route or track for the road therein mentioned, as shall to the best of their judgment and skill, combine shortness of distance with the most practicable ground, from the bank of the river Susquehanna, opposite the borough of Harrisburgh, through Carlisle and Bedford to Pittsburgh.

SECT. II.
