SECT. 1. Be it enacted by the senate and house of representatives of the commonwealth of Penusylvania, in general assembly

SECT. 111. And be it further enacted by the authority aforesaid, That the commissioners aforesaid, as soon as conveniently may be after the said letters patent shall be sealed and obtained, shall give notice in two or more of the newspapers, printed in the borough of Lancaster, of a time and place by them to be appointed, not less than twenty days from the publication of the first notice; at which time and place the subscribers shall proceed to organize the said corporation, and shall choose by a majority of votes of the said subscribers, then present, by ballot, to be delivered in person or by proxy duly uthorized, one president and ten managers, one treasurer, and such other officers as they shall think necessary to conduct the business of the said company for one year, and until such other officers shal be duly chosen; and the managers so chosen, and their successors, shall and may make such by-laws, rules, orders and regulations, not inconsistent with the constitution and laws of the United States, or of this commonwealth, as shall be necessary for the well ordering the affairs of the said company; and generally have like powers, authorities, and privileges, necessary for carrying on and completing the said turnpike road; and be subject to all the duties, qualifications, restrictions, penalties, fines and forfeitures, and be entitled to like tolls and profits, in proportion to the distance as are given and granted to the president, managers and company, of the Gap and Newport turnpike road; Provided, that no toll be demanded or taken from any person passing or re-passing from one part of his or her farm to another, or to and from any place of public worship, or funeral, to or from the militia on days of training; And provided also, that if the company shall not proceed to carry on the said work in three years after the passing of this act, or shall not within ten years after the passing of this act, complete the said road according to the true intent and meaning of this act, then and in either of these cases, all and singular the rights liberties and franchises hereby granted to the
