SECT. VI. And be it further enacted by the authority aforesaid, legislature to That the nonuser of the powers herein given, shall not work a forfeiture of them; but nothing herein contained, shall be deemed or taken as a promise from the legislature not to repeal or abridge them at any subsequent period.

## CHAPTER CLXIV.

An ACT to authorize the governor of this commonwealth to incorporate a company, for erecting a bridge over the river Tioga, at the village of Athens or Tioga Point.

Commissioners appointed.

SECT. 1. BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same, That Henry Wells, John F. Satterlee, John Shepard, David Paine, Stephen Hopkins, Clement Paine Thomas Overton, and William Means, be and they are hereby appointed commissioners, to do and perform the several duties hereinafter mentioned, that is to say, they shall on or before the first day of May next, provide a book or books as they shall think necessary, and write therein as follows: "We whose names are hereunto subscribed,

To procure books, &c.

do promise to pay to the president, managers, and company, for erecting a bridge over the river Tioga at Athens, on Tioga point, the sum of fifty dollars for every share of stock in the said company set opposite to our respective names, in such manner and proportions, and at such times as shall be determined by the president and managers in pursuance of an act of the general assembly, entitled an act to authorize the governor of this commonwealth to incorporate a company for erecting a bridge over the river Tioga, at the village of Athens, on Tioga point;" and shall And receive thereupon proceed to receive subscriptions for the stock of the subscriptions. said company at such times and places as they shall think proper; Provided always, that every person offering to subscribe as afore- Proviso. said, in his name or any other name, shall previously pay to the attending commissioner, five dollars for every share to be subscribed, which shall be paid over to the treasurer of the corporation, as soon as the same shall be organized, and the officers chosen as hereinafter mentioned.

SECT. 111. proceed to organize the said corporation, and shall choose by a majority of votes of the said subscribers, by ballot to be delivered in person, or by proxy duly authorized, one president and four managers, one treasurer, and such other officers as they shall think necessary to conduct the business of said company for one year, and until other officers shall be chosen; and may make such by-laws, orders, rules and regulations, not inconsistent with the laws of this commonwealth, as shall be necessary for the well-ordering the affairs of the said company; Provided, that no person shall have more than twenty votes at any election, or in determining any question arising at such meetings, whatever number of shares he or she may be entitled to, and that each person shall be entitled to one vote for every share by him or her held under the said number.

Number of votes limited.

SECT. IV. And be it further enacted by the authority aforesaid, That the fourth, fifth sixth, seventh, eighth, twelfth, fourteenth, and fifteenth sections of the act, entitled "An act to authorize the governor of this commonwealth to incorporate a company for creeting a bridge over the river Lehigh, near the town of Northampton," passed March the twenty-seventh, one thousand seven hundred and ninety-seven, are hereby declared to be equally binding and obligatory upon the said company intended to be incorporated by this act, except that part of the seventh section which directs publications in certain newspapers.

When the property in the bridge shall vest. And the right to demand and receive toll commence and how regulated.

Sect. v. And be it further enacted by the authority oforesaid, That when a good and complete bridg? is erected over the said river Tioga, at Athens, the property of the said bridge shall be vested in the said company as aforesaid, their successors and assigns, forever; and the said company, their successors and assigns, may demand and receive toll at the same rate and in every respect be governed by the same rules, which are prescribed by the ninth section of the aforesaid act entitled "An act to authorize the governor to incorporate a company for erecting a bridge over the river Lehigh, near the town of Northampton."
