Gettysburg, on the Gettysburg and Chambersburg turnpike road, and ending at the western end of Millerstown, and be subject to all the duties, qualifications, restrictions, penalties, fines and forfeitures, and be entitled to like tolls and profits in proportion Of tolls. to the distance as are given and granted to the president, managers and company, of the Susquehanna and York Borough turn- Proviso. pike road; Provided, that if the company shall not proceed to carry on the said work in three years after the passing of this act, or shall not within seven years afterwards complete the said road according to the true intent and meaning of this act, then in either of these cases, all and singular the rights, liberties and franchises, hereby granted to the said company, shall revert to this commonwealth.

CHAPTER CLXXV.

CHAPTER CLXXVI.
