

CHAPTER XIX.

An ACT to continue an act, entitled, "An act to incorporate the Insurance Company of the State of Pennsylvania.

SECT. I. BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same, That the act, entitled "An act to incorporate the Insurance Company of the State of Pennsylvania," passed the eighteenth day of April, one thousand seven hundred and ninety-four, and the supplement thereto, passed the fifth day of March, one thousand seven hundred and ninety-five, be, and the same are hereby continued in full force and virtue, and in all their parts, (except the clause of limitation in the original act,) for the term of twenty years, from and after the first day of January, one thousand eight hundred and fifteen, as if the present period of extension were part of the above recited act: *provided*, that if it shall appear, that the charter and privileges hereby renewed, are injurious to the citizens of this commonwealth, the legislature shall have full power to revoke and cancel them, at any time they may think proper:

The act incorporating the Pennsylvania Insurance company, and its supplements, extended twenty years.

CHAPTER XX.

An ACT to enable the executors of William Ball, deceased, to release certain lots from the payment of rents charge.

WHEREAS William Ball, late of the city of Philadelphia, died seized of divers yearly rents charge, issuing out of lots in the county of Philadelphia, extinguishable by the payment of certain sums of money mentioned in the deeds of conveyance of the said lots, and the tenants are desirous to extinguish the same; but the executors of the said William, are not, by his last will and testament, empowered to release the said lots from the payment of said rents charge: Therefore,

SECT. I. Be it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same, That Joseph Ball, John Hewston, and Joseph L. Ingles, executors of the last will and testament of William Ball, deceased, or the survivors or survivor of them, be, and they or he are or shall be authorized and empowered to execute releases of the rent charges

to the holders of such lots in the county of Philadelphia, the estate of William Ball, deceased, as by the covenants contained in the deeds for the said lots, are entitled to have such releases made and executed, according to the tenor and effect of the said covenants, on the payment of the monies, and performance of the covenants therein mentioned and contained.

CHAPTER XXI.

An ACT allowing an additional compensation to the commissioners appointed to view and ascertain the route for the turnpike road, from Harrisburg to Pittsburg.

Additional compensation allowed to the commissioners for viewing the route of a turnpike road from Harrisburg to Pittsburg.

SECT. 1. *BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same, That the sum of three dollars per day, be allowed to the commissioners who were appointed under the authority of the act, entitled, "An act to encourage the construction of certain great and leading roads within this commonwealth, and the erection of bridges over the river Susquehanna, at Harrisburg, Northumberland, Columbia, and McCall's ferry," for nine days service, in viewing the middle route by Newville and Roxbury, together with the expense of surveying and chain-carrying; and the accountant officers are hereby directed to admit and settle their accounts for the same.*
