poor of said county of Dauphin; and such paupers as may hereafter be in Lebanon county, shall be maintained and treated as was directed by law, before the erection of the house aforesaid.

Certain sections to be continued years, or until suitable buildings are erected.

Sect. xix. And be it further enacted by the authority aforesaid, That the sixteenth and seventeenth sections of this act, shall in force for three be, and continue in force for the term of three years, or until a jail shall be erected in the said county of Lebanon, and ready for the reception of prisoners, and approved of by the court and grand jury, who shall enter their approbation signed by them on the record of said court; and from thenceforth it shall be lawful for the sheriff of Lebanon county to receive all and every person or persons who may then be confined in the jail of Dauphin county, on legal process issued by proper authority from Lebanon county, and convey them to the jail of Lcbanon county, and to keep them in custody until they shall be discharged by due course of law.
