#### CHAPTER LXXIV.

*An ACT vesting in the guardians and overseers of the poor for the city and county of Philadelphia, a certain burial ground on the west side of Schuylkill near the upper ferry, for the use of the poor of said county.*

WHEREAS it appears, that a certain piece of ground situate on the west side of Schuylkill, near the upper ferry, in the county of Philadelphia, has been recognized as a burial ground from the earliest settlement of Pennsylvania, and which appears to be the property of this commonwealth; and whereas, the guardians of the poor for the above mentioned city and county, have no place for the interment of such poor persons as may die under their care: Therefore,

SECT. 1. *Be it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same, That the right and title of this commonwealth to the tract of land or burial ground above mentioned, situate on the west side of Schuylkill near the upper ferry, bounded by lands of Elizabeth Powell, and others, beginning at a post corner of Elizabeth Powell, or Bingham's land; thence extending by the same north seventy-two degrees, west fifty two perches, to a post, and east forty-three perches, to a post; thence by marsh land, south twenty-one degrees and a half east, seventeen perches and a quarter, to the place of beginning; containing about two acres and twenty-two perches, be the same more or less, be, and the same is hereby vested in and confirmed to the guardians and overseers of the poor, for the city and county of Philadelphia, and their successors, in trust to and for the use of the poor thereof, as a burial ground forever; provided always, that nothing herein contained*

CHAPTER LXXV.

*An ACT to enable the governor to incorporate a company for making an artificial road from the town of Manheim to the town of Richland, to meet New Haven street, at the point where the same intersects the Lancaster and Middletown turnpike in the county of Lancaster.*

SECT. I. *BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same, That* John Rohrer, George Myers, Christian Lipe, Jacob Erisman, Henry Strickler, Christian Metz, David Cassel, Samuel Ensminger, and Christian Metz, junior, of Abraham, of the county of Lancaster, be, and they are hereby appointed commissioners to do and perform the several duties hereinafter mentioned, that is to say, they shall on or before the first day of June next, procure one or more books, and enter therein as follows : "We whose names are hereunto subscribed, do promise to pay to the president, managers and company of the Manheim and Richland turnpike road company, the sum of one hundred dollars for each and every share of stock in the said company set opposite to our respective names, in such manner and proportions, and at such times as shall be determined by the said president and managers, in pursuance of an act of the general assembly of this commonwealth, entitled, "An act to enable the governor to incorporate a company for making an artificial road from the town of Manheim, to the town of Richland in the county of Lancaster."
