## CHAPTER SCVI.

An ACT to enable Alexander Mack, guardian of and for the minor children of Aguess Mack, deceased, to sell and convey two certain tracts of land to the purchaser there-

WHEREAS it hath been represented to the legislature, that Alexander Mack, the elder, by his last will and testament, in writing, devised one fifth part of his real estate, that is to say, thirty acres of land, be the same more or less, situate partly in Germantown township, and partly in Springfield township, in the counties of Philadelphia and Montgomery, unto the above named Agness Mack, and to her heirs and assigns for ever, as tenants in common; and whereas, the said Agness lately died intestate, leaving nine children, three whereof yet remain under the age of twenty-one years; and whereas, it appears by the records of the orphans' court of the counties of Adams and Bedford, that the above named Alexander Mack was legally appointed guardian of the persons and estates of the three minor children aforesaid; and whereas, it appears to be beneficial to the minors aforesaid, that their right and title to the aforesaid lands should be sold along with their other brothers and sisters' undivided parts of the aforesaid real estate: Therefore,

SECT. 1. Be it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same, That A.
