CHAPTER CVII.

An ACT authorizing the governor to incorporate a company, to make an artificial road from the town of Munchester, in the county of York, to intersect the York, Conewago, and Canal turnpike road, between the fifth and seventh mile stones.

SECT. 1. BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is bereby enacted by the authority of the same, That commissioners named. George Small and Andrew Cramer, of the county of York, Frederick Nagle, James Mehaffey, Matthias Rank, Lewis Leader, Abraham Zublin and Henry Cassel, of the county of Lancaster, be and they are hereby appointed commissioners to do and perform the several duties herein after mentioned, viz. names or in the names of any other persons who shall duly authorize the same for any number of shares in the said stock; Books to be kept and the said books shall be kept open respectively for the purpose aforesaid, at least six hours in every juridical day, for the space of three days, or until the said books shall have two hundred and twenty shares therein subscribed, and if at the expiration of the said three days, the books aforesaid shall not have the number of shares aforesaid therein subscribed, the said commissioners may adjourn from time to time, and may adjourn and transfer the said books from the borough of Marietta and the town of Manchester elsewhere, until the whole number of shares shall be subscribed, of which adjournments and transfers the commissioners aforesaid shall give such public notice as the occasion may require; and when the whole number of shares subscribed for in all the said books shall amount to two hundred and twenty shares, the same shall be closed; provided always, that every person offering to subscribe in the said books, in his own or any other name, shall previously pay to the attending commissioners the sum of five dollars for every share to be subscribed, out of which shall be defrayed the expenses of attending the taking of such subscriptions, and other incidental charges, and the remainder shall be paid over to the treasurer of the corporation, as soon as the same shall be organized, and the officers chosen as hereinafter mentioned.

And be it further enacted by the authority aforesaid, Letters patent may issue when the when thirty persons or more shall have subscribed eighthirty persons or ty shares of the said stock, the commissioners shall certify unmore have sub-That when thirty persons or more shall have subscribed eighder their hands and seals, the names of the subscribers, and the number of shares subscribed by each, to the governor; and thereupon it shall and may be lawful for the governor, by letters patent under his hand and seal of the state, to create and erect the subscribers, and if the said subscription be not full at the time, those also who shall afterwards subscribe to the number aforesaid, into one body politic and corporate, in deed and in law, by the name, style and title of, "The president Managers and Company of the Manchester turnpike road;" and by the said name the subscribers shall have perpetual succession, and all the privileges and franchises incident to a corporation, and shall be capable of taking and holding the said capital stock, and the increase and profits thereof, and of enlarging the same from time to time by new subscriptions, in such manner and form as they shall think proper, if such enlargement shall be found necessary to fulfil the intent of this act; and of purchasing, taking and holding, to them and their successors and assigns, of selling and transferring, and conveying in fee simple, or for any less estate, all such lands, tenements, hereditaments and estates, real and personal, as shall be necessary to them in the prosecution of their works; and of suing and being sued; and of doing all and every other matter and thing, which a corporation or body politic may
