CHAPTER CXC VII.

An ACT granting a tract of donation land to the legal heirs of John Knapsnyder, deceased, late a soldier in the Pennsylvania line.

SECT. 1. BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same, That the land officers be, and they are hereby directed to draw and patent a tract of donation land, containing two hundred acres, unto the legal heirs of John Knapsnyder, deceased, late a soldier in the Pennsylvania line, clear of patenting fees.

A SUPPLEMENT to "An act to amend and consolidate the several acts relating to the settlement of the public accounts and the payment of the public monies, and for other purposes."

SECT. 1. BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly

met, and it is hereby enacted by the authority of the same, That the several powers vested in, and duties enjoined on the state treasurer by the tenth section of the act to which this is supplementary, are hereby vested in and enjoined on the auditor general, except as to suits heretofore commenced in pursuance of said section.

CHAPTER CXCIX.

An ACT for the relief of the heirs of John Smith, an old soldier.

SECT. I. BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same, That the state treasurer pay unto Robert Gilmore of Mercer county, attorney in fact for the heirs of John Smith, the sum of sixty-five dollars for arrearages of pay.

CHAPTER CC.

A SUPPLEMENT to the act, entitled, "An act authorizing the governor of this commonwealth to subscribe to a loan opened by the government of the United States."

Bank of Pennsylvania authorized to loan money to the governor.

SECT. I. BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same, That the bank of Pennsylvania be and it is hereby authorized to lend to the governor of this commonwealth, such sum or sums of money as he may think proper to borrow from the said bank by virtue of the act to which this is a supplement, and upon the conditions therein mentioned, any thing in the act incorporating said bank, to the contrary notwithstanding.
