CHAPTER XCIII.

An ACT to erect the towns of Bellefonte and Smithfield in Centre county into a borough, and to repeal the act heretofore passed incorporating the borough of Bellifonte.

Bounds of the borough.

Sect. 1. BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is bereby enacted by the authority of the same, That the towns of Bellefonte and Smithfield, in the county of Centre, within the following boundaries, to wit, beginning at Spring creek where Lamb street adjoins the said creek, thence up the said street to the end thereof, thence so as to include all the out lots sold by the proprietors of the town of Bellefonte, thence to the head of the big spring, thence to spring creek including the spring and the creek therefrom in the borough, thence up spring creek to the lane which divides John McKees field from Benjamin William's lots, thence along said lane and the road leading to the Bellefonte mills to the north side of James Steele's lots, thence including said lots to the place of beginning, shall be and the same is hereby erected into a borough under the name and title of "The Borough of Bellefonte."

SECT. 11. Appropriation of self the duties of the said office shall neglect to discharge the same according to law, every person so refusing or neglecting, shall for every such offence forfeit and pay the sum of twenty dollars; which fine, and all other fines and forfeitures incurred and made payable in pursuance of this act, or of any of the bylaws and ordinances of the town council, shall be for the use of the said corporation, and shall be recovered in the same manner that debts not exceeding one hundred dollars are recoverable before a justice of the peace, and when so recovered, shall forthwith be paid to the treasurer of the borough: provided, that no person shall be compelled to serve more than once in any term of three

SECT. v. And be it further enacted by the authority aforesaid. That the chief burgess, assistant burgess, members of the town council, high constable, and each of them before entering upon the duties of their respective offices, shall take and subscribe an oath or affirmation before any justice of the peace of said county to support the constitution of the United States and of this state, and to execute the duties of their respective offices with fidelity; and the certificates of such oath and affirmation shall be filed among the records of the corporation.

And be it further enacted by the authority aforesaid, That the treasurer shall give security for the faithful discharge of the duties of his office, and for the safe delivery of all monies, books, and accounts appertaining thereto into the hands of his successor, upon demand made for that purpose.

Streets, lanes, &c. declared pub lic highways.

Supervisors appointed, and their duties.

SECT. X. And be it further enacted by the authority aforesaid, That all the streets, lanes and alleys in the said borough, are hereby declared public roads and highways; and it shall be the duty of the electors in the said borough, and they are hereby empowered to choose and elect two persons as supervisors of the public roads and highways within the said borough, who shall be chosen and elected agreeably to the general road laws of this commonwealth; and the said supervisors shall be subject to the same laws, entitled to the same emoluments, and vested with the same powers within the borough of Bellefonte as other supervisors are subject and entitled to within their respective townships in this commonwealth.

SECT. XI. And be it further enacted by the authority aforesaid. That the supervisors, treasurer, high constable, clerk of the marexhibit their accounts annually all other officers which may be appointed by the corporation or to the council chall at the guesterly meeting of the said council in the council shall, at the quarterly meeting of the said council in the month of May yearly, render their accounts to the said council for settlement; and the said accounts being adjusted and settled, shall be forthwith published by the said council, showing particularly and distinctly the amount of taxes laid and collected, and of all monies paid into the treasury, and the application and expenditure thereof.

Sect. XII. And be it further enacted by the authority aforesaid, Board of appeal. That the chief burgess, assistant burgess and president of the council, or any two of them, shall constitute a board of appeal; in case of any borough or water tax, other than the tax assessed and levied by the supervisors, and prior to the collection of any borough or water tax, the collector shall inform each inhabitant of the amount of his tax, and of the time and place of appeal: provided, that the said board shall have no other power than to determine the justness of the apportionment of said tax.

And be it further enacted by the authority aforesaid, That it shall be the duty of the high constable to give notice of the annual elections of the said borough to be held in pursuance of this act, by setting up four advertisements in public places in the said borough, six days previous thereto, and he shall attend and see that the election be opened at the time and in the manner directed by this act: provided, that it shall be the duty of the present high constable to publish and superintend in like manner the election to be held on the first Monday in May next, as

SECT. XIV. And be it further enacted by the authority aforesaid, That the town council shall from to time establish the compen-compensation to sation of the several officers created by this act, or appointed by officers them in pursuance thereof; and if any person appointed to any office by the town council, shall refuse to take upon himself the duties thereof, he shall forfeit and pay for the use of the corpo- Penalty on reration, any sum not exceeding ten dollars, unless he can render fusing to act. to the said council a satisfactory reason why he should be exonerated from such service: provided, that no person shall be compelled to serve more than one in three years.

SECT. XV. And be it further enacted by the authority aforesaid, That if any person or persons shall think him, her or themselves Appeal for reaggrieved by any thing done in pursuance of this act, he, she or ances to quarter they may appeal to the next court of general quarter sessions of the peace, to be held for the said county, upon giving security before a justice of the peace residing in the said borough, to prosecute his, her or their appeal with effect; and the said court having taken the premises into consideration shall make such order and decree therein as shall be just and reasonable, and the same shall be conclusive.

SECT. XVI. And be it further enacted by the authority aforesaid, That from and after the first Monday in May next, the act entitled "An act to erect the town of Bellefonte in Centre county into a borough," passed the twenty-eighth day of March, one pealed. thousand eight hundred and six, be and the same is hereby repealed; but the repeal thereof shall not affect any proceeding commenced in pursuance thereof, but the same shall be finished and concluded as if this act had not been passed,
