## CHAPTER CXXX.

An ACT for the relief of Martin Brechall, John Barr, Joseph Johnson, Daniel Dougherty and Charles Tipper, soldiers of the revolutionary war.

SECT. 1. BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same, That Annuity to Mar-tin Brechall. the state treasurer be and he is hereby directed to pay to Martin Brechall of Northampton county, or order, forty dollars, im-

mediately after the passing of this act.

And to John

SECT. 11. And be it further enacted by the authority aforesaid, That the state treasurer be and he is hereby required to pay to John Barr of Washington county, or order forty dollars, immediately, and an annuity of forty dollars to commence on the first day of January, eighteen hundred and fourteen, and be paid half yearly.

Certain monies to be paid to Jo-seph Johnson and D. Dough r.

SECT. III. And be it further enacted by the authority aforesaid, That all money that is due, or shall hereafter become due to Joseph Johnson, and Daniel Dougherty of Butler county, old soldiers, by an act passed the tenth day of March, one thousand eight hundred and twelve, shall be paid to themselves, or orders, any act to the contrary notwithstanding.

Annuity to Charles Tipper.

SECT. IV. And be it further enacted, by the authority aforesaid, That the state treasurer be and he is hereby required to pay to Charles Tipper of Bedford county, or order, the sum of forty dollars, immediately.

## CHAPTER CXXXI.

An ACT for the aid of Harrisburg Academy.

SECT. 1. BE it enacted by the senate and house of representtatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same, That there is hereby granted to the trustees of the Harrisburg Academy and to their successors forever, the following described part of the public ground in the borough of Harrisburg, to wit: Beginning at the corner of High and Walnut-streets, thence up High-street, eighty-eight feet six inches, thence south forty-five degrees, west, one hundred and sixty-three feet four inches, thence by a straight line, to Walnut-street to a point one hun-

dred and fifty-eight feet four inches from the place of beginning, and thence in a straight line to the place of beginning, containing fifty-six perches and eight tenths, for the purpose of erecting thereon a building for said academy and for no other purposes whatsoever.

WHEREAS it appears to the legislature that Walter Clark, late of Londonderry township, in Dauphin county, deceased, did in his life-time sell by parole to Samuel Thompson, three acres of ground situate in the same township being a part of the said Walter Clark's land on which he resided at the time of his decease, at forty dollars per acre, and died not having made any provisions for completing said contract, and that the full balance of the purchase money has since been paid to James Wilson and William Cathcart executors of the last will and testament of the said Walter Clark: therefore,

SECT. 1. Be it enacted by the senate and bouse of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same, That the aforesaid executors of Walter Clark, deceased, be and they are hereby enabled to convey by deed to the said Samuel Thomp-son in fee simple the said three acres of ground sold as aforesaid water Chark to with the appurtenances as effectually as he the said Walter Clark convey certain could do if in full life.
