

tween them, when in fact it was expressly agreed between the contracting parties last mentioned, that thirty-three acres and fifty-three perches should be reserved out of that part of the land which fell to the share of said testator to the said John Orr in trust, and for the use and benefit of the said George Graham, and that the said reserved land never was in possession of said testator, but held by said trustee for the purposes aforesaid. And it is further represented that said testator made no provision in his life time for re-conveying the same to the said George Graham, and as by the existing laws of this commonwealth no authority vests in the executrix and executor aforesaid to make said conveyance: Therefore,

SECT. I. *BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same, That Magdalena Hawk, executrix, and Martin Renninger, executor, of the will and last testament of John Hawk, deceased, are hereby authorized to make and execute a good and sufficient title to George Graham, his heirs, and assigns, for thirty-three acres and fifty-three perches of land, situate in East Pennsborough township, in the county of Cumberland, which title shall be as good and available in law as if it had been made by the said John Hawk in his life time. Provided,* that nothing in this act contained shall be understood to injure or prejudice the right of any other person or persons.

## CHAPTER CXLVIII.

*An ACT to authorize the accountant officers of this commonwealth to open their accounts with William Henderson, late treasurer of Montgomery county.*

WHEREAS it is represented to the legislature that William Henderson was appointed treasurer of the county of Montgomery, for the years eighteen hundred and one two and three, and on the final settlement of his accounts, found that the several returns made by the commissioners of the exempts during the said term, were eleven hundred and seventy dollars and nineteen cents more than he actually received from the collectors in charging him with debits that had been allowed by them, and that he is now barred by the act of limitation to obtain redress; Therefore,

SECT. I. *BE it enacted by the senate and house of representatives of the commonwealth of Pennsylvania, in general assem-*

*bly met, and it is hereby enacted by the authority of the same,*  
That it shall be lawful for the auditor general and state treasurer, to open and settle the accounts of the commonwealth, with William Henderson, late treasurer of the county of Montgomery, as fully and effectually as though no act of limitation had intervened, any law to the contrary notwithstanding.

CHAPTER CXLIX.

*An ACT for altering a part of the state road from Blair's Gap to the western boundary line of the state, in Mercer county, and for other purposes.*

A certain road  
made public.

SECT. I. *BE it enacted by the senate and house of representatives, of the commonwealth of Pennsylvania, in general assembly met, and it is hereby enacted by the authority of the same,* That a road beginning at White's quarry, east of Neshanack creek, on the state road from Blair's gap to the western boundary of the state, near the town of Newcastle, in the county of Mercer, thence running westwardly, so as to cross the said creek opposite Washington street, in the town of Newcastle aforesaid, thence along the said creek to Shenango river, thence across the said river, thence on a north-westwardly direction so as to intersect the aforesaid state road at or near the top of Byers' Hill, a distance of about three-fourths of a mile, be and the same is hereby established a public road and highway, of the width of sixty feet, and shall be part of the state road aforesaid.

SECT. II. *And be it further enacted by the authority aforesaid,* That John Carlisle Stewart, John Sankey, and Crawford White, of the county of Mercer, be and they are hereby appointed commissioners, whose duty it shall be to lay out, survey and make a draft or plot of the said road, the draft or plot whereof shall be deposited by them and remain a record in the office of the clerk of the court of quarter sessions of the said county, and a copy of the same forwarded to the secretary of the commonwealth, to be filed in his office; and the said commissioners shall each receive the sum of one dollar and fifty cents, as a full compensation for said service, to be paid by the county of Mercer, aforesaid. And the supervisors of the township or townships through which the said road may pass, are hereby enjoined to open and keep the same in repair, under the same rules, restrictions and remedies, provided for opening and keeping in repair roads laid
