## CHAPTER XXV.

Sect. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That it shall be lawful to and for the undertakers of public bridges within this commonwealth, their superintendants, artists and workmen of every kind, to enter into and upon any lands, tenements and enclosures, near to the places where said bridges are to be built, and to examine the ground for the purpose of opening quarries of stone, and for obtaining gravel, clay, sand and other materials necessary for the building of said bridges, and to enter with teams of any kind, first giving notice to the owners, doing as little damage as possible, and repairing any breaches of fences they may have occasion to make; and first making amends for any damages that may be done, which damages shall be ascertained by the parties if they can agree, or if they cannot agree, then by appraisement thereof, to be made upon oath or affirmation, by three disinterested freeholders of the neighborhood, or any two of them, to be mutually chosen, or if the owners or undertakers, or superintendants, upon due notice, shall neglect or refuse to join in the choice, then the said freeholders to be appointed by any justice of the peace of the county, not interested on either side, and the said, undertakers or other persons by them employed, as aforesaid, after tender of the appraised value, may enter and dig, take and

carry away any stone, gravel, sand or clay most conveniently situated, for the purpose of erecting and repairing said bridges.

An ACT to erect Pottstown, in the county of Montgomery, into a borough.

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That Pottstown Pottstown, in the county of Montgomery, be, and the same is crected into hereby erected into a borough; bounded and limited as follows, a borough. that is to say, Beginning at a stake on the northern bank of the river Schuylkill, thence through Jacob Lesher's land, north twen-Its boundaty-five degrees, east one hundred perches, to a post on the eastries side of the road leading from the Monatawney ford on Schuylkill to Glasgow; thence by the east side of said road, north fifteen degrees, east forty-seven perches, to Beach street; thence by Beach street, and on the line dividing the lands of the estate of the late Mary Jones, deceased, from the lands of Mary Graham, David Rutter, the estate of Clifford Smith, deceased, and Joanna Potts, south eighty degrees, east two hundred and twenty-five perches, to a stake in a line of Peter Richard's land; thence through Peter Richard's land, south fifty-eight degrees, east sixtythree perches, to a post, and south twenty-four degrees, west one hundred and eleven perches, to a post a corner of Jacob Hubley's land; thence on the line which divides Jacob Hubley's land from Peter Richard's land, south forty-one degrees thirty minutes, west eighty-three perches, to the river Schuylkill; thence up the said river, the several courses thereof, two hundred and sixty-eight perches, to the place of beginning.

SECT. II. And be it further enacted by the authority aforesaid,
