## CHAPTER LIX.

An ACT authorizing John Snyder and Peter Cook, trustees of the German Presbyterian congregation in Guilford township, Franklin county, to sell and convey certain lands therein mentioned.

SECT. I. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That John Snyder and Peter Cook, trustees of the German Presbyterian congregation in Guilford township, in the county of Franklin, be, and they are hereby authorized to sell and convey, in fee simple, or otherwise, about thirty-nine acres and one hundred and forty-four perches, being part of a certain tract of land, containing in the whole fifty-one acres and one hundred and forty-four perches and the usual allowance, adjoining lands of Daniel Hellman, Daniel Bonebrake and land late of Ezekiel Chambers, and that after deducting the necessary expenses attending the said sale and conveyance, the said trustees, or their successors, shall put the proceeds thereof out at interest, or purchase bank stock therewith for the use of said congregation.

## CHAPTER LX.

An ACT to authorize Ralph Funk and John W. Burson, executors of the estate of Henry Funk, deceased, to make and execute a title for a certain lot of land therein mentioned.

WHEREAS it hath been represented to the legislature, that Henry Funk, late of Bucks county, deceased, did in his life time, by parole contract, agree to sell and convey unto John Funk, a certain lot of land, containing six acres, for the sum of forty-eight dollars: And whereas, it hath been further represented, that the said John Funk paid unto the said Henry Funk, deceased, in his life time, the sum of forty-eight dollars, in full of the said consideration money for said lot of land: And it further appearing that the said Henry Funk died without making a deed of conveyance, unto the said John Funk for said land: Therefore,

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That Ralph Funk and John W. Burson, executors of the estate of Henry Funk, late of Springfield township, in the county of Bucks, deceased, be, and they are hereby authorized to make and execute a deed of conveyance unto John Funk, his heirs and assigns, for a lot of Ralph Funk land in the township of Springfield, and county of Bucks, bounded and John W. by lands of Jacob Reinsimer, Jacob Funk and Henry Funk, junior, Burson to containing six acres; which deed, when so executed, shall be con-make a deed, sidered as good and available in law, as if it had been executed by &c. the said Henry Funk in his life time: Provided, That the rights of any individual or individuals shall not be affected by any thing contained in this act.

## CHAPTER LXI.

An ACT to incorporate the Penn's Manor meadow company, in the county of Bucks.

Sect. 1. BE it enacted by the Senate and House of Representatiues of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That Charles Ellet, Isaac Parson, Samuel Reynolds, John Hume, Robert Crozer, Samuel Crozer, Barclay Ivins, Hector Thompson, Isaac Robbins, of the county of Bucks, John Geyer and Adolph Eringhaus, of the city of Philadelphia, executors of John De Karns, deceased, and their successors, be, and they are hereby declared to be a body politic and corporate, in law and in fact, by the name, style and title of "The Penn's Manor Meadow Company," and by the name, Style of corstyle and title aforesaid, to have and enjoy all the usual and neces-poration. sary powers of bodies politic and corporate.

Sect. 11. And be it further enacted by the authority aforesaid,
That each member of the company, their heirs and successors, proportion of shall pay to the trustees, for the time being, his, her or their pro-expenses to portion of all expenses incurred or to be incurred by the trustees be paid by hereinafter named, and their successors appointed as hereinafter members. mentioned, in such manner as the company at their annual meet-

ings shall from time to time direct.

SECT. III. And be it further enacted by the authority aforesaid,
That the general meetings of the company shall be held on the second Saturday of January annually, and it shall be the duty of the Annual meettrustees for the time being, to give each member timely notice of the time and place of holding such meeting.

SECT. 1V. And be it further enacted by the authority aforesaid, 3 trustees to That at the said annual meeting, the members present shall elect, 3 trustees to by ballot, three of their members trustees for one year, who shall elected. examine the accounts of the trustees of the preceding year, which
