CHAPTER LXV.

A SUPPLEMENT to the act, entitled "A further supplement to the act, entitled "an act authorizing the governor to incorporate a company for making an artificial road from the bank of the river Susquehanna, opposite Harrisburg. to Pittsburg."

WHEREAS, the legislature of Pennsylvania did, on the ninth day of March, Anno Domini one thousand eight hundred and fourteen, pass an act making the borough of Somerset a point in the Harrisburg and Pittsburg turnpike road, and as it has since been deemed injurious to the state of Pennsylvania, inasmuch as a sufficient number of shares have not been sold, agreeably to the said act, so as to authorize the governor to incorporate companies for making so much of said road as lies between Bedford and Greens burg, and that a great part of the road, if taken by way of the borough of Somerset, would have to pass over an uninhabited and mountainous part of the country: And whereas, the old Pennsylvania road is well known to be much shorter than the Somerset route. the ground much more suitable for a turnpike road, and the materials more convenient: Therefore,

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That Stoystown, in the county of Somerset, be, and the same is hereby made a point through which the artificial road from the bank of the made a point river Susquehanna opposite Harrisburg to Pittsburg, shall pass, inin said road. stead of the borough of Somerset in said county, as fully to all intents and purposes, as though the town of Stoystown, and not the borough of Somerset, had been mentioned in the said act; any law

or laws to the contrary notwithstanding.

Sect. 11. And be it further enacted by the authority aforesaid, That as soon as the company shall have been incorporated, for making an artificial or turnpike road from Bedford to Stoystown, the governor is hereby authorized to subscribe, on behalf of this Governor to commonwealth, for one thousand three hundred shares of the stock 1300 shares. of said company: And as soon as the company shall have been incorporated, for making an artificial or turnpike road from Stoystown to Greensburg, the governor shall be, and he hereby is authorized to subscribe, on behalf of this commonwealth, for one thousand three hundred shares of the stock of said company.

Sect. iv. And be it further enacted by the authority aforesaid, Repealing That so much of the said act to which this is a supplement, as is section. hereby altered or supplied, be, and the same is hereby repealed.

CHAPTER LXVI.

An ACT directing the secretary of the land office, to issue patents to the assignees of John Nicholson, for certain lands therein mentioned.

WHEREAS it has been represented to the legislature, that John Nicholson, on the twenty-first day of April, seventeen hundred and ninety-four, applied for two hundred and two thousand four hundred acres of land, and gave a check on the Bank of Pennsylvania for the purchase money, which was presented and dishonored; upon which he tendered twenty-seven thousand two hundred and sixtyone dollars and thirty-three cents, the purchase money, on the fourteenth day of June, seventeen hundred and ninety-four, which was refused: and that the said John Nicholson transferred his right to the said application, to Joseph Boone, who obtained the decree of the board of property for warrants to issue in his favor thereon, which was transferred by him to Philip Nicklin and Robert E. Griffith, merchants, in company; and it having been found, by exploring the county, that about eighty thousand acres remained unappropriated, which might be applied in part satisfaction of the said application; on the nineteenth of March, eighteen hundred and five, the said Philip Nicklin and Robert E. Griffith paid, in moieties, ten thousand seven hundred and twenty dollars, the purchase money on eighty thousand four hundred acres, upon which warrants there-
