A SUPPLEMENT to the act, entitled "An act to erect part of Northumberland county into a separate county, to be called Union."

Sect. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That from and after the first Monday of May next, the several courts Courts of in and for the county of Union, shall be opened and held in the Union to be court house in the town of New Berlin, in the said county, and it held at New shall be the duty of the several officers in the said county of Union, who now, by law, are obliged to hold their offices in the county town, to remove their respective offices to the said town of New Berlin, on or before the first Monday of May aforesaid; any law to the contrary notwithstanding: Provided, That a full and a sufficient deed, in fee simple, for the court house and lot whereon the same shall have been erected, shall, on or before the first Monday in April next, be tendered to the commissioners of the said county, on the payment of sixty-seven cents by them.

CHAPTER LXXII.

An ACT establishing an Academy in Lewistown, in the county of Mifflin.

Sect. 1. BE it enacted by the Senate, and House of Representatives, of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That Academy to there shall be, and hereby is established in Lewistown, in the coun-be built in ty of Mifflin, an academy for the education of youth in the useful Lewistown arts, sciences and literature, by the name and style of "The Lew-

istown Academy."

SECT. 11. And be it further enacted by the authority aforesaid, That until the first of April, eighteen hundred and sixteen, the trustees of the Lewistown academy shall consist of the following persons, to wit: The reverend James Johnston, reverend William Kennedy, reverend John Hutcheson, reverend Thomas Smith, reverend John Coulter, David Reynolds, James Knox, Matthew Tay-Trustees of lor, William Lyon, Richard Hope, James Sharard, Robert M'Clel-said academy land, William P. Maclay, John Oliver and Andrew Banks, which a body polisaid trustees, and their successors to be elected as hereinafter ditic. rected, shall be, and hereby are declared to be one body corporate and politic, by the name, style and title of "The Trustees of the

Lewistown Academy," and by the same name shall have perpetual succession, and shall be able to sue and be sued, plead and be impleaded in all courts of record and elsewhere, and shall be competent and capable in law and equity, to take and to hold, to them and their successors, for the use of said academy, lands, tenements, hereditaments, goods and chattles of what kind, nature or quality soever, by gift, grant, bargain, sale, conveyance assurance. will, devise or bequest from any person or persons whomsoever, capable of making the same: Provided the same do not exceed the yearly value of five thousand dollars: and the same from time to time to grant, bargain, sell, demise, alien, lease or dispose of for the use of said academy, and to erect such building as may be necessary, and generally to do all and singular the matters and things which shall be lawful for them to do for the well being of the said academy, and the due management and ordering the affairs thereof.

Sect. III. And be it further enacted by the authority aforesaid. Of a common That the trustees of said academy, and their successors, shall have full power and authority to use one common seal, and the same to

alter at their pleasure.

Sect. iv. And be it further enacted by the authority aforesaid, That the said trustees shall hold their first meeting, in Lewistown, on the first Monday in May next after the passing of this act, and shall meet on the first Monday in May in each succeeding year. 8 trustees to any eight of whom shall constitute a quorum, who shall have the power of transacting the business of the said academy, particularly in making and enacting ordinances and by-laws for the government thereof, of electing trustees in the room of those who may be removed by death, resignation, or otherwise, of electing and appointing masters and tutors for said academy, of agreeing with them for and paying their salaries, and at their pleasure removing the same, of appointing a secretary and other necessary officers, of taking care of the funds and managing the concerns of the corporation, and of determining all matters and things necessary to be determined and transacted by said trustees: Provided, That no ordinance or by-law shall be contrary to the constitution or laws of the United States, or of those of this state.

And be it further enacted by the authority aforesaid, That the first election for trustees of said academy, shall be holden on the first Monday in April, in the year of our Lord one thousand eight hundred and sixteen, and on the first Monday of April annually thereafter, and no person or persons shall be entitled to vote at said election, unless he or they shall have previously become a subscriber to the stock or funds of said academy.

Sect. vs. And be it further enacted by the authority aforesaid, Proceedings That all by-laws, ordinances, and proceedings of the corporation, shall be fairly and regularly entered in a book to be kept for that tees to be en-purpose; and no misnomer of the said corporation shall defeat or annul any gift, grant, devise or bequest to the said corporation: Provided the intent of the parties shall sufficiently appear on the face of the gift, grant, will or other writing whereby any estate or other interest, was intended to pass to the said corporation; nor shall any nonuser of the rights, liberties, privileges, jurisdictions
