CHAPTER LXXV.

An ACT for the relief of Jacob Gitt.

SECT. I. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same,* That the act entitled "An act for the relief of insolvent debtors," passed the twenty-sixth day of March, one thousand eight hundred and fourteen, be, and the same is hereby extended to the case of Jacob Gitt, so as to relieve him from imprisonment, as fully to all intents and purposes as though the said Jacob Gitt had resided within this state for six months, immediately preceding his confinement in the county of Adams.

CHAPTER LXXVI.

further SUPPLEMENT to the act, entitled "An act for erecting part of the counties of Mifflin, Northumberland, Lycoming and Huntingdon into a separate county."

SECT. I. *BE it enacted by the Senate and House of Representa-*

Trustees of Centre county to make settlement.

tives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That from and after the passing of this act, all the powers and authorities heretofore given by law to the trustees of Centre county, be, and the same are hereby vested in the commissioners of the said county of Centre, and their successors, and the office of trustees of the county of Centre is hereby abolished; and it shall and may be lawful for the commissioners of Centre county to call the said trustees to a settlement of their accounts, as well as all other person or persons who may owe or be indebted in any sum or sums of money arising, owing or accruing to the said county, under or in pursuance of the ninth section of the act to which this is a further supplement, and to receive and compel the payment of the same, with the legal interest that may or shall hereafter accrue thereon; which monies shall be expended by the said commissioners agreeably to the provisions of the said act, and the said commissioners shall, from time to time, render due and faithful accounts of all monies received, and the expenditures of the same, to the auditors of the county of Centre, who shall adjust and settle the same.

Of the commissioners contracts.

SECT. II. *And be it further enacted by the authority aforesaid, That all contracts made or entered into by the commissioners of Centre county, for the building of a new jail, in the borough of Bellefonte, are hereby declared to be good and valid in law, any thing in any act or acts of assembly to the contrary notwithstanding; and all acts relating to the said county of Centre, which are hereby altered or supplied, be, and the same are hereby repealed.*

CHAPTER LXXVII.

An ACT authorizing the executors named in the last will and testament of William Hoge, deceased, and the administrators of Samuel Miller, late of Washington county, deceased, to complete the titles to certain lots of land.

The executors of Wm. Hoge to make deeds, &c.

SECT. I. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the executors named in the last will and testament of William Hoge, late of Washington county, deceased, are hereby authorized and required to execute deeds of conveyance to the purchasers, their heirs or assigns, for lots sold by him in his lifetime, on parole contract, in all cases where the claimants shall be able to prove, to*
