## CHAPTER CXIII.

An ACT to provide for the prescrvation of arms, camp equipage and other military property belonging to this commonwealth.

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the governor be, and he is hereby authorized and required, immediately after the passing of this act, to call upon the several brigperty, reports ade inspectors within this commonwealth, to make out a true list of all the arms, camp equipage and military stores of every description, the property of this commonwealth, within the bounds of their respective brigades, and make return thereof to him on or be fore the first day of June next; and he shall take such further measures as may appear necessary for the security and preservation; thereof, and may direct the sale of such of the property, implements and military stores aforesaid, as are of a perishable nature, and not suitable for military purposes: Provided, That it shall be his duty to give information to the next legislature of whatsoever he shall have done under the provisions of this act, stating particularly the number of arms, the quantity and different kinds of camp equipage and military stores, and the state of preservation and repair in which they may then respectively be. Sect. 11. And be it further enacted by the authority aforesaid,

That the governor be, and he is hereby authorized, to draw his

## CHAPTER CXIV.

An ACT authorizing Paul Morrow and Samuel Guthrie, guardians over the persons and estates of the minor children of George Hays, deceased, to sell and convey a lot of ground therein mentioned.

WHEREAS, it has been represented to the legislature, that Paul Morrow and Samuel Guthrie, of Greensburg, in the county of Westmoreland, guardians over the persons and estates of Jane and George Hays, minor children of George Hays, of Kittanning, in the county of Armstrong, deceased, being seized, at the time of his death, of a certain lot of ground in the town of Kittanning, in the county aforesaid, known on the general plan of said town, by in-lot number two hundred and twenty-two, fronting on Jefferson street, and adjoining lots number two hundered and eighteen, and two hundred and twenty-six; that a frame house is erected on the said lot, but is unfinished and in a perishable condition, and of no benefit to the estate; the children are small, and the estate insufficient for their education and maintenance: Therefore,

Sect. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That Paul Morrow and Samuel Guthrie, guardians of the minor children of George Hays, deceased, be, and they are hereby authorized to sell, by public sale, at such times, and upon such terms, as shall appear to them most for the interest of said minors, a certain lot of ground in the town of Kittanning, in the county of Armstrong, marked in the general plan of said town, by in-lot number two hundred and twenty-two, fronting on Jefferson street, and adjoining lots number two hundred and eighteen, and two hundred and twenty-six, and to execute a sufficient and valid deed thereof to the purchaser; and the said guardians shall apply the money arising from the sale aforesaid, as may appear to be best calculated to promote the interest of said minors: Provided, That previous to selling the lot of ground aforesaid, the said Paul Morrow and Samuel Guthrie shall enter into bonds, with sufficient security, to be approved by
