And be it further enacted by the authority aforesaid, Extension of That the president, managers and company of the Perkiomin and Reading turnpike road be, and they are hereby authorized to extend their turnpike road into the borough of Reading, to the intersection of Penn street and Prince street, under the same provisions, privileges and restrictions as are contained in the act which authorized their incorporation, and the supplement thereto: Provided, That no toll gate shall be erected within the borough of Reading.

Perkiomin turnpike company.

Secr. III. And be it further enacted by the authority aforesaid, That the president, managers and company of the Perkiomin and Powers of the Reading turnpike road, from and after the passing of this act, shall have like power and privileges to those given and granted to the president managers and company of the Berks and Dauphin turnpike road, by the thirteenth section of the act entitled, "An act authorizing the governor to incorporate a company for making an artificial road from the river Schuylkill at Reading, in the county of Berks, to or near Hummelstown, in the county of Dauphin, passed the second day of March, one thousand eight hundred and five, or may, at their discretion, ask, demand and receive from all and every person or persons using said roads, with a waggon or other carriage drawn by four or more horses, the breadth of the wheels of which shall be less than four inches, for every five miles, one cent additional for each horse drawing the same.

## CHAPTER CXVIII.

An ACT providing for repairing the State House in the city of Philadelphia.

Sect. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the commissioners of the county of Philadelphia be, and they are hereby authorized and required, to take charge of the State House delphia coun in the city of Philadelphia, and to let the same, in the name of the commonwealth, on such terms and for such uses as to them may appear advisable, giving a preference of all the upper part of the

Charge of State House in the Philaty commissioners.

house, with the use in common of the entry and stairway, to the proprietor of the Museum, at the rate of four hundred dollars per annum, and should the proprietor of the Museum refuse to accept the apartments thus allotted him, at the rate prescribed by this act, then the said commissioners are hereby authorized and directed to let the same to the best and highest bidder: Provided, That the said commissioners shall not have power to lease the said house, or any part thereof, at any one time for a term exceeding one year: And provided also, That no expense to be incurred for repairs, shall exceed the amount of rent for the same time.

SECT. 11. And be it further enacted by the authority aforesaid, How rents That the rents and profits arising by this act shall be, and the shall be same are hereby appropriated, under the directions and manage appropriated ment of the aforesaid commissioners, to the improvements and repairs of the said state house; and it shall be the duty of the said commissioners, to keep a fair account of the receipts and expenses,

and annually transmit a copy thereof to the auditor general.

Sect. III. And be it further enacted by the authority aforesaid, Resolution That so much of the resolution of the legislature, passed the seven-of 1802 teenth day of March, in the year one thousand eight hundred and repealed. two, as directs that it shall be the duty of Charles Wilson Peale, to take charge and care of the state house, be, and the same is hereby repealed.
