CHAPTER XXXII.

An ACT establishing an Academy in the borough of Lebanon, in the county of Lebanon.

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That there shall be, and hereby is established in the borough of Lebanon, in the county of Lebanon, an Academy for the education of youth in the useful arts, sciences and literature, by the name

Andrew Shulze, Peter Shindel, Samuel Light, John Harrison, Edward Godwin, doctor George Reidenaur, doctor Duncan King, Philip Greenawalt, Philip Wolfersberger, junior, Peter Linawever, Abraham Dæbler, John Batdorff and Jacob Weidman, which said trustees and their successors, to be elected as hereinafter directed, shall be, and hereby are declared to be one body corporate and politic, by the name, style and title of "The Trustees of the Lebanon Academy," and by the same name shall have perpetual succession, and shall be able to sue and be sued, plead and be impleaded in all courts Powers and of record and elsewhere, and shall be competent and capable in law and equity, to take and to hold, to them and their successors, for the use of the said academy, lands, tenements, hereditaments, goods and chattles of what kind, nature or quality soever by gift, grant, bargain, sale, conveyance, assurance, will, devise or bequest from any person or persons whomsoever capable of making the same: *Provided* the same do not exceed the yearly value of five thousand dollars: and the same from time to time to grant, bargain, sell, demise, alien, lease or dispose of, for the use of said academy; and to erect such buildings as may be ne-

And be it further enacted by the authority aforesuid, That the first election for trustees to said academy, shall be holden on the first Monday in April, in the year of our Lord Of elections. one thousand eight hundred and seventeen, and on the first Monday of April annually thereafter, and no person shall be Qualification entitled to vote at said election unless he shall have previously of electors. become a subscriber to the stock or funds of said academy: Proviso. Provided, That if the annual election shall not be made on the stated day, it shall and may be lawful on any other day, as soon as may be, to hold and make an election of said trustees in such manner as shall be regulated by the by-laws and ordinances of

the said corporation.

Secr. vi. And be it further enacted by the authority aforesaid, That all by-laws, ordinances and proceedings of the corporation shall be fairly and regularly entered in a book to be kept for that purpose, and no misnomer of the said corporation shall defeat or annul any gift, grant, devise or bequest to the same: Provided the intent of the parties shall sufficiently ap-proviso. pear on the face of the gift, grant, will or other writing whereby any estate or other interest was intended to pass to the said corporation, nor shall any non-user of the rights, liberties, privileges, jurisdictions and authorities hereby granted to the said corporation, create or in any wise cause a forfeiture thereof.

And be it further enacted by the authority aforesaid, That no sale or alienation of the real estate of the said Of alienation corporation, which may be made by the said trustees or their of the prosuccessors, bona fide, for a valuable consideration, in case the pertypossession thereof pass immediately to the purchaser or purchasers, and continue in him, her or them, his, her or their heirs or assigns shall be invalidated for want of proving that nine of said trustees of said corporation consented to such sale and alienation, unless the same be controverted within the space of three years from and after the sale and delivery of such real estate to the purchaser or purchasers thereof.

SECT. VIII. CHAPTER XXXIII.

An ACT authorising the election of a constable in the borough of Greensburg.

Sect. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the electors of the borough of Greensburg, in the county of Westmoreland, shall annually, at the court-house in said berough, on the same day appointed for the election of constables in the different townships in this commonwealth, elect two reputable citizens in said borough, and return the names of the persons so elected, to the next court of quarter sessions of said county, one of whom shall be appointed in the same manner, under the same provisions, and subject to the same penalties as are provided and contained in the act entitled, "An act to amend and consolidate with its supplements, the act, entitled An act for the recovery of debts and demands not exceeding one hundred dollars before a justice of the peace, and for the election of constables, and for other purposes,?
