CHAPTER LIX.

A further SUPPLEMENT to an act, entitled "An act to incorporate a company for making an artificial road from Harrisburg, through Lewistown and Huntingdon, to Pittsburg."

SECT. 1. Sect. III. And be it further enacted by the authority aforesaid, That John Denniston, of Indiana county, and William Commission-Johnston, of Westmoreland county, be, and they are hereby apers named. pointed commissioners for receiving subscriptions to the stock of said road, in addition to the commissioners heretofore appoint-

ed.

SECT. IV. And be it further enacted by the authority afore-said, That it shall hereafter be lawful for the said company to Notice of republish in one newspaper printed in the city of Philadelphia, scriptions to one printed in the borough of Harrisburg, one or more printed be given. in the borough of Huntingdon, one printed in the borough of Greensburg, and one printed in the town of Indiana, the notice required by the seventh section of the act of the twenty-fourth of March, one thousand eight hundred and six, and such publication of notice, shall be of the same validity, and have the same force and effect, as if the same had been made in the manner directed by said section.

Shor. v. And be it further enacted by the authority aforesaid, That, until otherwise directed, it shall be lawful for the Mile-stones. said company, to paint on the mile-stones to be erected, the distance from the commencement and from the end of said road, in lieu of the distances from the city of Philadelphia and the borough of Harrisburg, as required by the nineteenth section of the act of the thirty-first of March, one thousand eight hundred

and seven.

SECT. VI. And be it further enacted by the authority aforesaid, That the governor be, and he is hereby authorised and re-Governor to quired to appoint one suitable person, who shall he a practical appoint sursurveyor, who, together with one person to he appointed by the veyor, &c. president and managers of the said company, shall measure the

distance of the road which the said company are authorised to make from the borough of Huntingdon to the crossings of the Big Connemaugh, and thereby ascertain the proportional parts of the monies appropriated by the act of the twenty-fourth of March, one thousand eight hundred and twelve, to be paid to the said company; and so much of any act as is hereby altered, be, and the same is hereby repealed.
