

CHAPTER LXIX.

A SUPPLEMENT to the act, entitled "An act for the appointment and regulation of constables in the township of the Northern Liberties, in the county of Philadelphia."

SECT. I. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That* from and after the passing of this act, the electors of the township of the Northern Liberties shall, on the third Saturday in the month of March in each and every year, elect four suitable persons, inhabitants of said township, in addition to the eight persons to be elected by the act to which this is a supplement, and return the names of such additional persons so elected, to the next general court of quarter sessions to be held for the county of Philadelphia, and the said court shall appoint two of them constables for said township, and shall also have the same power to appoint another proper person to serve the office of constable for and during the term or residue of the term which the person in whose room he shall be so appointed was entitled to serve, as is given in the act to which this is a supplement.

Two additional constables to be appointed for N. Liberties.

SECT. II. *And be it further enacted by the authority aforesaid, That* before either of the said additional constables of said township shall enter on the duties of his office, he shall become bound by recognizance, as is provided for in the act to which this is a supplement, and the act entitled, "An act to amend and consolidate with its supplements the act, entitled 'An act for the recovery of debts and demands not exceeding one hundred dollars, before a justice of the peace, and for the election of constables, and for other purposes,'" passed the twentieth of March, one thousand eight hundred and ten, and shall also be liable to all the restrictions and entitled to all the privileges, emoluments and fees that the present constables of the Northern Liberties are.

CHAPTER LXX.

A SUPPLEMENT to the act, entitled "An act to incorporate the city of Philadelphia."

SECT. I. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly*

met, and it is hereby enacted by the authority of the same, That from and after the passing of this act, the mayor, recorder and aldermen of the city of Philadelphia, or any three or more of them, whereof the mayor or recorder for the time being, shall be one, shall have full power and authority, and they are hereby vested with full power and authority to hold the mayor's court for the city of Philadelphia, as fully and effectually as the said mayor, recorder and aldermen, or any four of them might or could do by virtue of the twentieth section of the act to which this is a supplement, and generally to do, execute and perform all and singular the powers and authority vested in the said mayor, recorder and aldermen by the said twentieth section of the act aforesaid.

CHAPTER LXXI.

An ACT enabling Peter Pedersen to purchase and hold real estate within this commonwealth.

WHEREAS, it has been represented to the legislature, that Peter Pedersen, minister from Denmark, has, for many years past, resided in the United States, and now wishes, with a view to his future continuance in the state of Pennsylvania, to purchase and hold such real estate as will enable him to form a permanent and convenient residence; and that owing to his public official station, he is unable to declare an intention to become a citizen of the United States: Therefore,

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That Peter Pedersen be, and he is hereby authorised and enabled to take by purchase, or otherwise, any lands, tenements and hereditaments within the state of Pennsylvania, and the same to hold to him, his heirs and assigns, in fee simple or otherwise, as fully and effectually, to all intents and purposes, as if he were a citizen of the United States: Provided always, That such real estate as aforesaid shall not exceed, at any one time, two hundred acres of land with the improvements thereon.*
