CHAPTER LXXXIII.

An ACT to incorporate the town of Strasburg, in the county of Lancaster.

Sect. 1. And be it further enacted by the authority aforesaid, That from and after the first Tuesday in April next, the chief burgess, assistant burgess and town council duly elected as aforesaid, and their successors, shall be one body, politic and corporate, by the name and style of "The Chief Burgess, As-Style of sistant Burgess and Town Council of the Borough of Strasburg," corporation. and shall have perpetual succession; and the said chief burgess, assistant burgess and town council, and their successors, shall be capable, in law, to have, receive, hold and possess goods and Powers and chattels, lands, tenements, rents, liberties, jurisdictions, fran-privileges. chises and hereditaments, to them and their successors, in fee simple or otherwise, not exceeding the yearly value of five thousand dollars, and also to grant, sell, let, and assign the same lands, tenements, hereditaments and rents; and by the name and style aforesaid they shall be capable in law to sue and be sued, plead and be impleaded in any of the courts of law of this commonwealth, in any manner of actions whatsoever, and to have and to use one common seal, and the same from time to time at their will to change and alter, until it be otherwise

directed by law.

Sect. iv. And be it further enacted by the authority aforesuid, That the chief burgess, assistant burgess and president of the council, or any two of them, shall constitute a court of appeals, peal, and prior to the collection of any borough tax, the collector shall inform each inhabitant of the amount of his tax, and of the time and place of appeal: Provided, nevertheless, That the said court of appeal shall have no other power, as such, than to determine the justness of the apportionment of said tax, and to remedy any grievance that may occur in imposing the same.

SECT. XII. And be it further enacted by the authority aforesaid, That if any person or persons shall think him, her or themselves aggrieved by any thing done in pursuance of this act, except in what relates to the imposing and collecting the borough tax and appointments made by the town council, he, she or they may appeal to the next court of common pleas to be held for the said county, upon giving security according to law, to prosecute his, her or their appeal with effect, and the said court having taken such order therein as shall seem to them just and reasonable, the same shall be conclusive.

CHAPTER LXXXIV.

An ACT to authorise the surveyor of the township of the Northern Liberties, in the county of Philadelphia, to re-survey, lay out and regulate Slesman's alley, in the incorporated district of the Northern Liberties.

SECT. I. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the surveyor of the district of the Northern Liberties be, and he is hereby authorised and required to regulate, lay out and resurvey Slesman's alley in the incorporated part of said district, so that the descent of the said alley shall, instead of running castwardly as by the original survey, run east and west from a part in said alley to be fixed and determined upon by the surveyor of said district; and the same proceedings shall be had after the said regulation and re-survey, as is directed by the act entitled, "An act to incorporate that part of the township of the
