time affix the salaries of the high constable, town clerk, treasurer, clerk of the market and such other officers as may be appointed under this act, which salaries shall be paid out of the borough treasury, by orders drawn thereon signed by the president of the council, which salaries shall not be increased or diminished during the time for which the said officers were appointed respectively: *Provided*, That if any person appointed by the town council as aforesaid, shall neglect or refuse to take upon himself the duties of the office to which he shall be appointed, he shall for the same, forfeit and pay, for the use of the corporation, the sum of ten dollars, unless he can render to the said council a satisfactory reason why he should be exonerated from such service: *And provided also*, That no person shall be compelled to serve more than once in five years.

SECT. XIV. And be it further enacted by the authority aforesaid, That if any person or persons shall think him, her or themselves aggrieved by any thing done in pursuance of this act, except in what relates to the imposing and collecting the borough tax and appointments made by the town council, he, she or they may appeal to the next court of common pleas to be held for the said county, upon giving security according to law, to prosecute his, her or their appeal with effect, and the said court having taken such order therein as shall seem to them just and reasonable,

the same shall be conclusive.

CHAPTER LXXXIV.

An ACT to authorise the surveyor of the township of the Northern Liberties, in the county of Philadelphia, to re-survey, lay out and regulate Slesman's alley, in the incorporated district of the Northern Liberties.

Sect. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the surveyor of the district of the Northern Liberties be, and he is hereby authorised and required to regulate, lay out and resurvey Slesman's alley in the incorporated part of said district, so that the descent of the said alley shall, instead of running castwardly as by the original survey, run east and west from a part in said alley to be fixed and determined upon by the surveyor of said district; and the same proceedings shall be had after the said regulation and re-survey, as is directed by the act entitled, "An act to incorporate that part of the township of the

Northern Liberties lying between the west side of Sixth street and the river Delaware, and between Vine street and the Co-hocksink creek," passed the twenty-eighth day of March, one thousand eight hundred and three.

CHAPTER LXXXV.

An additional SUPPLEMENT to an act, entitled "An act to incorporate a company for making an artificial road from Harrisburg, through Lewistown and Huntingdon, to Pattsburg."

SECT. I. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That for the purpose of making a turnpike road from the town of New Alexandria to the bank of the river Connemaugh, in Westmoreland county, opposite the point at which the Huntingdon, Cambria and Indiana turnpike road shall intersect the said river, the Commission. following persons, to wit, Nicholas Day, William Denniston, ers named. Zebulon Doty, Joseph Barnes and James Reed, be, and they are hereby appointed commissioners to do and perform the duties hereinafter mentioned, viz: They shall procure a certain number of books, and in each of them enter as follows, "We, whose names are hereunto subscribed, do promise to pay the president and managers of the New Alexandria and Connemaugh turnpike road company the sum of fifty dollars for every share by us subscribed, in such manner and proportions, and at such times and places as shall be determined by the said president and managers, in pursuance of an act entitled 'An additional supplement to an act entitled, An act to incorporate a company for making an artificial road from Harrisburg, through Lewistown and Huntingdon, to Pittsburg. Witness our hands this in the year of our Lord one thousand eight day of ." And shall give notice at least for one hundred and calendar month in one or more newspapers printed in the towns Notice of of Pittsburg, Greenesburg, New Alexandria, Indiana and Hunt-opening ingdon, of the times and places when and where the said books books. shall be kept open to receive subscriptions of stock to the aforesaid company, at which respective times and places some one or more of the aforesaid commissioners shall attend and receive subscriptions from all persons of lawful age who shall offer to who may subscribe in the said books, and every person offering to sub-
