## CHAPTER IX.

## AN ACT

. Authorising the Governor to incorporate the Kennet and Downingtown Turnpike Company.

Sect. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That James Jefferies, William Downing, Humphrey Marshall, William Webb, Jesse John, Isaac Trimble, Isaac Bennet, Caleb Brinton, jun. and James Jones be, and they are hereby appointed commissioners to do and perform the several duties herein after mentioned, that is to say, they shall on or before the first Monday in May next, procure two or more books, and in each of them, enter as follows, to wit: "We whose names are hereunto subscribed, do promise to pay to the president, managers and company of the Kennet and Downingtown turnpike subscription road, the sum of fifty dollars each, for every share of stock in said company, set opposite to our respective names, in such manner and in such proportions and at such times, as shall be determined by the president and managers of said company. Witness our hands the day of one thousand Public notice to be given of tight hundred and seventeen." And shall thereupon give pub-

Provided always, That every person offering to subscribe in his own name or any other name, shall previously pay to the attending commisto be paid on sioners, the sum of three dollars for every share to be sub-

scribed, out of which shall be defrayed the expenses attending .

Sect. 2. state, as shall be necessary for the well ordering the affairs of the company, and generally have like powers, authorities and with the Lit privileges necessary for carrying on and completing the said turnpike road, and be subject to all the duties, qualifications,

restrictions, penalties, fines and forfeitures, and be entitled to like tolls and profits, in proportion to the distance, as are givven and granted to the president, managers and company of the Little Conestoga turnpike road. Provided, that if the company shall not proceed to carry on the said work in four years after the passing of this act, or shall not within ten years afterwards complete the same according to the true intent and meaning of this act, then in either of these cases, all and singular the rights, liberties and franchises, hereby granted to the said company, shall revert to this commonwealth.

Sect. 5. And be it further enacted by the authority aforesaid, That if the company authorised by this act to be incorporated, shall at any time issue any note or notes in the nature of bank notes, or carry on any business in the nature of banking, then or in either of those cases, all the powers and privileges granted by this act shall cease and be determined.

## AN ACT
