## CHAPTER XXXI

#### AN ACT

Authorising the Governor to incorporate the President, Managers and Company of the Bethany and Canaan turnpike road.

Commissioners named.

Sect. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That Moses Thomas, esquire, Isaac Dimmick, Jason Torrey, Mathias Keen and George Rix, of Wayne county, be, and they are hereby appointed commissioners to do and perform the several things hereinafter mentioned, that is to say, They shall, on or before the first day of June next, procure a book and enter therein as fo'lows, "We whose names are hereunto subscribed, do promise to pay to the President, Managers and Company of the Bethany and Canaan turnpike road, the sum of twenty-five dollars for every share of stock set opposite to our respective names, in such manner and proportions and at such times as shall be determined by the president and managers of the said company, in pursuance of an act of the General Assembly of this Commonwealth, entitled 'An act authorising the Governor to incorporate the president, managers and company of the Bethany and Canaan turnpike road. And be it further enacted by the authority aforesaid, That it shall be lawful to and for the said president and managers, their superintendants, surveyors, engineers, artists and chain bearers, to enter in and upon all and every the lands, tenements and enclosures in, through and over which the said intended turnpike road may be thought proper to pass, and examine the ground most proper for the purpose, as well as the materials in the vicinity that will be necessary in making and constructing the said road, and to survey, lay down, ascertain, mark and fix such route or track for the same road, as in the best of their judgment and skill will combine shortness of distance with the most practicable ground, from Rix's gap in the Moosic mountain, in Canaan township, to the town of Bethany, and thence passing through Bethany, on Court street, to the Coshecton and Great-bend turnpike road near the house of Benjamin Conklin, in Damascus township, in Wayne county, and generally they shall have like powers, authorities and privileges necessary for carrying on and completing the said turnpike road, as well as for all the subsequent concerns of the corporation, and be subject to all the duties, Coshecton & qualifications, restrictions, penalties, fines and forfeitures, and be entitled to like tolls and profits, in proportion to the distance, as are given and granted to the president, managers and company of the Coshecton and Great-bend turnpike road: Provided, That if the company shall not proceed to carry on

And be it further enacted by the authority aforesaid, That if the company hereby authorised to be incorporated, shall at any time issue any note or notes in the nature of bank notes, or carry on any business in the nature of banking, then or in either of these cases all and singular the rights, privileges and franchises hereby granted to the said company, shall cease and revert to this Commonwealth.
