CHAPTER LIX.

AN ACT

To authorise the commissioners of Allegheny county to sell and convey part of a lot of ground in the city of Pittsburg, together with the jail of said county thereon erected.

SECT. 1. BE it enacted by the Senate and House of Revresentatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the commissioners of the county of Allegheny be, Commissioners may sell and they are hereby authorised and empowered to sell and jail and lot of dispose of by public sale, to the highest and best bidder, (first giving thirty days notice in at least two of the newspapers printed in the city of Pittsburg, of the time and place of sale) all that part of a lot of ground in said city whereon the common jail of Allegheny county now stands, together with said jail, and to make a good and sufficient deed or deeds, in fee simple, to the purchaser or purchasers of the same; and the monies arising from such sale or sales, shall be, by the said commissioners, applied to the purchase of another lot of ceeds to be ground in said city, or its vicinity, and to the erection of a appropriated jail thereon; and the said commissioners shall, for the faithful expenditure of the same, account to the auditors of said county, in the same manner as they are by law obliged to account for the expenditure of all other public monies: Provided, That nothing herein contained shall affect the right of any person or persons.
