Sidneyville, Belinstown, Byardstown, Lawrenceville and Wilkinsburg, in the county of Allegheny, and all other towns and villages that now are or may be laid out within ten miles of the line of the city of Pittsburg, and in every part of the counties of Lancaster, Montgomery, York, Dauphin, Franklin and Lebanon, and mechanics and others in the said places shall have like remedy, under the said act and the said second section of the supplement thereto, for securing and recovering payment for their labor and materials for erecting any house or other building within the said places.

CHAPTER CIX.

AN ACT

BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That Luke M'Guire, executor of the last will and testament of Michael Murphy, late of Cambria county, deceased. be, and he is hereby authorised, by any sufficient deed or deeds. to release and convey to John Laney, in fee simple, the tract of land whereon he, the said John Laney, now lives, situated in Southampton township, Bedford county, containing one hundred and four acres and a quarter, and allowance, being part of a large tract called Armagh, containing three hundred and thirteen acres and one hundred and fifty-two perches and allowance, granted to said Michael Murphy, by patent dated the first of February, Anno Domini one thousand seven hundred and ninety-nine: Provided, That said Laney shall fully comply with the contract on his part, and shall release to the assignee or assignees of said Michael Murphy, deceased, all his, the said John Laney's, title and claim of and to a tract of one hundred acres of land or thereabouts, adjoining the afore described tract, and sold by said Michael Murphy in his lifetime to Leonard Nickum.
