CHAPTER CXXXI.

A FURTHER SUPPLEMENT

To "An act to regulate the fisheries in the river Susquehanna and its branches.

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the saine. That the times and periods during which it is unlawful for any person or persons to cast or draw, or to direct, permit or aid the casting or drawing of any seine or net in the river Susquehanna and its branches, according to the second section of the supplement to the act to which this act is supplementary, passed the first day of March, one thousand eight hundred and fifteen, shall commence at sun rise of the days mentioned in the said section of said act, and end at sun rise of the days next succeeding.

CHAPTER. CXXXII.

AN·ACT

Authorising the trustees of the Low Dutch congregation in Adams county, to sell and convey a certain piece of land.

WHEREAS it is represented to the Legislature, that Cornelius Cosyn did, by deed, convey to Francis Cossart, David Vandine and David Demorast, in trust for the use of the Low Dutch congregation of Calvinists, a certain piece of land containing about one acre. And whereas the said trustees are all deceased, and the members of said congregation have become attached to other congregations, the house and land are now lying waste, and the members have prayed the Legislature to appoint trustees to sell and convey the same:

Therefore.

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That it shall be lawful for Wilhelmus Hooghtalen, Jacob Cassat and Garret Brinkerhoof, or the survivors or survivor of them, as trustees to sell and convey a certain piece of land, with the building thereon erected, situate in Straban township, Adams county, containing about one acre, which was conveyed by Cornelius Cosyn to trustees, for the use of the Low Dutch congregation of Calvinists in the township and county aforesaid, and the proceeds of such sale shall be applied by the said trustees, or the survivors or survivor of them, towards erecting a permanent wall around the burying ground connected with the said church, and the remainder to such religious purpose as a majority of those who were formerly members of the said congregation, and now reside in the said county of Adams, shall recommend in writing.
