

SECT. 65. *And be it further enacted by the authority aforesaid,* That Cherrytree township, and that part of Sugar creek township which formerly elected at the house of Thomas Gott, in Venango county, shall be a separate election district, and the electors thereof shall hold their general elections at the house now occupied by James Hamilton, in Cherrytree township. Venango.

SECT. 66. *And be it further enacted by the authority aforesaid.* That the electors of East Huntingdon, and the parts of Hemfield and Mount Pleasant townships, in the county of Westmoreland, now composing a district, shall hold their general elections at the house now occupied by John Loyd, innkeeper, in the town of Mount Pleasant. CHAPTER CLXIX.

AN ACT

To authorise the sale of certain real estate, late the property of Peter Albert, deceased.

WHEREAS it has been represented to the Legislature, that Peter Albert, late of Mahanoy township, in the county of Northumberland, deceased, (now Upper Mahanoy township) lately died, leaving a widow and issue Peter, Elizabeth (intermarried with Moses Vail) Rachel (intermarried with John Darreck) Phillipina (intermarried with John Bundy) Eve (since deceased) leaving issue one child (George Darreck) and Margaret: that the said Peter Albert, by his last will and testament, did devise to his wife for life, remainder in fee to his said children, two certain tracts of land situate in the township aforesaid: that the widow of the said Peter Albert is also since deceased: that the aforesaid Margaret,

daughter of the said Peter Albert, has, by due course of law, been declared a lunatic, and Jacob Zartman, Adam Linker and Abraham M'Kinney appointed a committee to take care of her person and estate. And whereas the said real estate is unproductive, and it would be more for the benefit of the devisees that the same should be sold; and the heirs of the said Peter Albert by themselves, together with the aforesaid committee, having prayed that Samuel Bloom, esquire, of Augusta township, may be authorised by law to sell and convey the real estate aforesaid, for the use and benefit of the said heirs:

Therefore,

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same,* That Samuel Bloom, of Augusta township, in the county of Northumberland, be, and he is hereby authorised to sell by public sale, upon such terms as shall be most for the benefit of the heirs of Peter Albert, deceased, late of the said township and county, all that certain message and tract of land, situate in the township of Upper Mahanoy and county aforesaid, adjoining lands of Henry Latcha, senior, Widow Boyer and others, containing one hundred and sixteen acres, and all that other tract of land situate in the same township and county, adjoining lands of Henry Latcha, junior, Widow Smith and others, containing twenty-two acres and one hundred and thirty perches, whereof the said Peter Albert died seized; the proceeds of which sale the said Samuel Bloom is required to pay over to the heirs of the said Peter Albert, according to their respective shares and proportions therein; the share or proportion due to Margaret Albert, a lunatic and daughter of the said Peter Albert, the said Samuel Bloom is required to pay unto Jacob Zartman, Adam Linker and Abraham M'Kinney, the committee appointed by the court of common pleas of the said county of Northumberland to take care of the person and estate of the said lunatic: and the said Jacob Zartman, Adam Linker and Abraham M'Kinney, are hereby required to place the money arising and received from such sale as the share of the said Margaret in the said real estate, at interest, upon good real security, or invest the same in some productive stock or fund, for the benefit and support of the said Margaret Albert, a lunatic as aforesaid: *Provided,* That the said Samuel Bloom shall, before proceeding to exercise the power and perform the duties given to or enjoined on him by this act, enter into recognizance with sufficient sureties, before the orphans' court of Northumberland county, conditioned for the faithful execution and performance of the same, and for the payment over without delay to the committee of the said Margaret, and to the other devisees and heirs of the said Peter Albert, deceased, of the shares of the pro-

CHAPTER CLXX.

AN ACT

For the relief of Thomas Bingham.
