CHAPTER CLXXVII.

AN ACT

Authorising the Governor to incorporate the Washington and Pittsburg turnpike road company.

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That David Atcheson, Alexander Murdock, David Commission-Shields, Alexander Reed, Parker Campbell, John Hoge and ers named. Thomas H. Notice of the ed in the borough of Washington, and two printed in the city of opening of Pittsburg, one calendar month, of the times and places the books. where the said books shall be opened to receive subscriptions of stock for the said company, at which respective times and places two or more of said commissioners shall attend, and permit all persons of lawful age, who shall offer, to subscribe. in the said books in their own name, or the names of any other Who may person or persons who shall duly authorise the same, for any subscribe. number of shares in the said stock; and the said books shall be kept open respectively for the purpose aforesaid at least six hours in every juridical day for the space of six days, or until the said books have two thousand shares subscribed, or if at the expiration of the said six days, the books as aforesaid shall not have the said two thousand shares subscribed, then May adjourn the sald commissioners may adjourn from time to time until and transfer the whole number of shares be subscribed, of which adjourn-books.

ments the commissioners aforesaid shall give such public notice as the occasion may require, and when the whole number of shares subscribed shall amount to two thousand, the same shall be closed: Provided always, That every person offering to subscribe in the said books in his own name, or in the name of any other person, shall previously pay to the attending commissioner or commissioners, the sum of two dollars and fifty cents for every share to be subscribed, out of which shall be defrayed the expenses attending in taking such subscriptions and other incidental charges, and the remainder shall be paid over to the treasurer of the said corporation, as soon as the same shall be organized and the officers chosen as hereinafter mentioned.

said, That when fifty persons or more have subscribed five When letters hundred or more shares of the said stock, the said commissioners respectively may, or when the whole number of shares aforesaid shall be subscribed, they shall, under their hands and seals, certify to the Governor the names of the subscribers and the number of shares subscribed by each, and thereupon it shall be lawful for the Governor, by letters patent, under his hand and the seal of the state, to create and erect the subscribers, and if the subscription be not full at the time. then also those who shall afterwards subscribe to the number aforesaid, into one body politic and corporate, in deed and in law, by the name, style and title of "The Washington and Pittsburg Turnpike Road Company;" and by the said name the said subscribers shall have perpetual succession, and all the privileges and franchises incident to a corporation, and shall be capable of taking and holding their capital stock and the increase and profits thereof, and of enlarging the same from time to time by new subscriptions, in such manner and form as they shall think proper, it such enlargement shall be found necessary to fulfil the intent of this act, and of purchasing, taking and holding, to them and their successors and assigns, and of selling, transferring and conveying, in fee simple or for any lesser estate, all such lands, tenements, hereditaments and estate, real and personal, as shall be necessary to them in the prosecution of their works, and of suing and being sued, and of doing all and every other matter and thing which a corporation or body politic may lawfully do. ,
