And be it further enacted by the authority aforesaid, That the president and managers shall meet at such times and places as shall be directed by their bye laws, and when met five members shall be a quorum, and in the absence of the president, a chairman may be chosen of the number met, and all their transactions, as well as every matter and thing relating to the affairs of the corporation, shall be entered in a book or books to be kept for such purposes; and a quorum being formed, they shall have full power to employ and contract with engineers, artists and such workmen as they may deem necessary to carry on and complete their intended works, as well as to uphold, alter and repair the same, and also to fix the times and manner, and in what proportion the stockholders shall pay the monies due on their respective shares, and to draw on the treasurer for all monies that may be required to carry into full effect this act, or that may be required by their bye-laws, rules and regulations, and generally to do all such other matters and things, as by this act, or their bye-laws, rules and regulations they shall be authorised to do.

And be it further enacted by the authority aforesaid, That it shall be the duty of the president and managers, as soon as may be after the company shall be organised, to proceed and bring, introduce and convey water into the town of Berwick, (Provided, That the consent of the owners of the land on which such spring or stream may be situate, is previously obtained,) by means of pipes, trunks or aqueducts, and also to provide proper cisterns or reservoirs for the reception thereof; and for these purposes may enter into such lands and enclosures as may be necessary, and to dig, ditch and lay pipes through the same, the company doing as little damage as possible to private property, and paying for whatever injury shall be done by them; when the parties cannot agree according to an assessment made by three disinterested freeholders, not being stockholders, to be appointed on application by the court of common pleas in and for the county of Columbia, and who shall be duly sworn or affirmed, justly and truly to make such assessment, reserving to the party thinking him, her or themselves aggrieved, the right of appealing therefrom as in other cases, to the court of common pleas aforesaid, and reserving nevertheless, to all those who may be affected by the diversion of the water, or by laying trunks through their lands, the full effect of the conditions and reservations in their respective concessions already made. And the president and managers shall at all times (paying damages as aforesaid) have liberty to renew and repair the Liberty to lay trunks wherever laid on and through private property, doing pipes, &c. as little damage as possible; and also shall have liberty at all times to dig and lay pipes and trunks along roads and highways, and the streets and alleys of the town of Berwick, and to renew and repair the same, shutting up and amending any breaches, which they may respectively make, as soon as possible; and it shall be lawful for them to make cisterns and reservoirs in the streets or public ground in the said borough, where the same may be necessary.

CHAPTER XXIX.

AN ACT

To creet the town of Berwick, in the counties of Columbia and Luzerne. into a Borough.

Berwick erected into a borough.

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the The town of same, That the town of Berwick in the counties of Columbia and Luzerne shall be, and the same is hereby erected into a borough, to be called "The borough of Berwick," comprised within the limits drawn, purporting to be a town plot of said Berwick, by Evan Owens, made in the year one thousand se-Limits there-ven hundred and eighty-six, beginning at the westerly shore of the north-east branch of the river Susqueltanna, at the point where the road leading from Salem to Berwick intersects the town line of Berwick at the river; thence north thirty degrees, west to a post three hundred and five perches; thence south sixty degrees, west two hundred and seventy perches to a post; thence south thirty degrees, east to the Susquehanna river; thence up said river to the place of beginning.
