during the time he served as a forage master in colonel Rees Hill's regiment of Pennsylvania militia; and the State Treasurer is hereby required to pay the amount so found due to the said M'Clean.

CHAPTER XLIII.

AN ACT

Incorporating the Presbyterian Congregation of Salem in Derry towiff ship, in the county of Westmoreland.

Sect. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That the trustees of the Presbyterian congregation congregati shall be, and they are hereby erected into one body politic gation in Derand corporate in deed and in law, by the name, style and ry township, title of "The trustees of the Presbyterian congregation of land county, Salem in Derry township, in the county of Westmoreland," incorporated. and by the same name shall have perpetual succession, and be able to sue and be sued, plead and be impleaded in all courts of law and elsewhere, and shall be able and capable in law and equity, to take and to hold to them and their successors for the use of said congregation, lands and tenements, goods and chattels of whatever kind, nature or quality, real, personal or mixed, by gift, grant, bargain, sale, conveyance, assurance, will, devise or bequest from any person or persons whomsoever, capable of making the same, and to erect such buildings, and do all other lawful acts and things for the interest, well being, and due management of the affairs of said congregation, as a majority of the members of said congregation may direct: Provided, That the yearly value or income of said estate or money shall not at any time exceed twelve hundred dollars.

SECT. 2. And be it further enacted by the authority aforesaid, That the trustees of said congregation shall be five in

number, and until others shall be appointed shall consist of

trustees, and the following named persons, viz. Hugh Culbertson, Robert M'Millan, Thomas Gallagher, James Guthrie and William Sterling, to continue until the first Tuesday of January Two trustees eighteen hundred and nineteen, and on the same day yearly to be elected thereafter the members of the congregation shall at a general

gation.

triennially by meeting thereof elect by ballot five persons to serve as trustees to continue in office three years. If any vacancy by death or otherwise shall happen in the office of trustees, the remaining trustees may elect others to supply such vacancy how supplied until the next general meeting of said congregation, at which meeting the congregation shall elect another trustee to fill the vacancy of the person through whom the vacancy happened.

CHAPTER XLIV.

AN ACT

Granting a sum of money to the county of York, for the purposes therein mentioned.

WHEREAS it appears that an inundation awful and distressing in its consequences was lately experienced in the county of York, that in addition to great private calamities it has been attended with heavy losses of a public nature, and application has been made to the legislature for relief.

Wherefore,

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That the State Treasurer be, and is hereby directed to pay unto the commissioners of the county of York the sum of five thousand dollars, to be applied by them in remissioners of building and repairing public bridges in said county which York county, were destroyed or injured by the late inundation, to be accounted for by them in the usual manner; and the said com-Commission- missioners are hereby required to give bond with sufficient security to the Governor for the faithful application of the said sum according to the intent and meaning hereof.

The State Treasurer to pay \$5,000 to the com-

ers to give security.
