And whereas it was found expedient for the well being of said congregation to sell eighty-one acres and allowance of the said tract of land unto Christian Luckenbill, who transferred his right to the aforesaid eighty-one acres and allowance to his son Abraham Luckenbill who is now in possession thereof, but the said congregation having no act of incorporation, no conveyance was executed to either the said Christian Luckenbill or Abraham Luckenbill. For remedy whereof,

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That Conrad Kirshner, Jacob Philips, John Staudt and Jacob Schwenk, or a majority of them, be, and they are hereby authorised and empowered to make and execute to Abraham Luckenbill, his heirs and assigns, a good and sufficient deed in fee simple, and in due form of law acknowledge the same, for a certain tract of land situate in Manheim township, in Schuylkill county, containing eighty-one acres and allowance, being part of a larger tract of land which was granted by the commonwealth of Pennsylvania, by patent bearing date the eleventh day of December one thousand eight hundred and seventeen, unto the aforesaid Conrad Kirshner, Jacob Philips, John Staudt and Jacob Schwenk, in trust for the Lutheran Congregation of St. Paul's church in the township aforesaid: Provided, That nothing in this act contained shall in any wise impair the rights of any individual or individuals.*

CHAPTER XLVIII.

AN ACT

In relation to arms, camp equipage, military stores and other articles furnished by the state of Pennsylvania, in the late war with Great Britain.

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General*

Assembly met, and it is hereby enacted by the authority of the same, That the Governor be, and he is hereby authorised and required to cause the necessary measures to be taken to ascertain the quantity and value of the arms, camp equipage, military stores, and other articles furnished by this state for the use of the militia thereof in the service of the United States, in the late war with Great Britain, and which had been retained in the said service on the discharge of the militia and not since returned, and procure an adjustment and payment of the same by the United States; and the necessary expenses which may be incurred in carrying the foregoing provisions into effect, shall be paid by warrants of the Auditor General on the accounts being settled in the usual manner, out of any monies in the treasury not otherwise appropriated.

CHAPTER XLIX.

AN ACT

To erect the town of Chester and its vicinity, in the county of Delaware, into a borough, and for other purposes therein mentioned.

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That the town of Chester and its vicinity, in the county of Delaware, comprised within the following limits, to wit. Beginning on the river Delaware at the mouth of Lemokin run at low water mark, thence up the said river to the mouth of Ridley creek, thence up the said creek to the line dividing the lands of Jeremiah M'Ilvain and Hugh Roberts, thence a straight course to the line dividing the lands of Joseph Engle and the heirs of Joseph Neide, deceased, thence along said line to the middle of the public road leading to Middletown, thence down the middle of said road to Ship creek, thence down the said creek to where the same empties into Chester creek,*
