SECT. 1. And be it further enacted by the authority aforesaid, That when fifty persons or more have subscribed five hundred or more shares of the said stock, the said commissioners respectively may, or when the whole number of shares aforesaid shall be subscribed, they shall under their hands and seals certify to the Governor the names of the subscri- When letters bers, and the number of shares subscribed by each, and there-patent may upon it shall be lawful for the Governor by letters patent un issue. der his hand and the seal of the state, to create and erect the subscribers, and if the subscription be not full at the time, then also those who shall afterwards subscribe to the number aforesaid, into one body politic and corporate, in deed and style and in law, by the name, style and title of "The Pittsburg and title. Steubenville Turnpike Road Company," and by the said name the said subscribers shall have perpetual succession, and all Rights and the privileges and franchises incident to a corporation, and privileges. shall be capable of taking and holding their capital stock and the increase and profits thereof, and of enlarging the same from time to time by new subscriptions, in such manner and form as they shall think proper if such enlargement shall be found necessary to fulfil the intent of this act, and of purchasing, taking and holding to them and their successors and assigns, and of selling, transferring and conveying in fee simple or for any lesser estate, all such lands, tenements, hereditaments, and estate real and personal, as shall be necessary to them in the prosecution of their works, and of suing and being sued, and of doing all and every other matter and thing which a corporation or body politic may lawfully do. Sect. 4. And be it further enacted by the authority aforesaid, That as soon as the company shall have been organised as aforesaid, they shall proceed to lay out and make said road by the way of Monteur's meeting house in Allegheny county, Briceland's cross roads in Washington county, from thence to the state line in a direction towards Steubenville; and as soon as five miles or more of the road aforesaid shall have been completed, the president and directors shall give notice thereof to the Governor, who shall thereupon nominate and how the road appoint three skilful, disinterested and judicious persons to may be view- view and examine the same who shall be under oath or affirmation, and report to him whether the road is made and executed in a competent and workmanlike manner; and if their report shall be in the affirmative, then the Governor shall by license under his hand and seal of the commonwealth, permit and suffer the president and managers to erect and fix such and so many gates or turnpikes upon and across the said road as will be necessary and sufficient to collect the tolls which the company respectively shall be entitled to demand

> SECT. 5. And be it further enacted by the authority aforesaid, That if the legislature should at any time after the year one thousand eight hundred and thirty, think proper to take possession of said road, three persons shall be appointed by the Governor, three persons by the president and managers of the said company, and three by the judges of the supreme court, who are hereby required to appoint the same, who or any six or more of them not having any interest in the said road, shall proceed to examine and estimate the value of the property which the said company have therein, and certify the amount thereof to the Governor, who shall cause the same to he laid before the legislature at their next session, and whenever the amount so certified shall be paid by the state to the

said company, their right to take toll on the said road, toget ther with all their right, title, claim and interest therein shall cease and determine.

### CHAPTER LXXVII.

#### AN ACT

Declaring the west branch of Oil Creek in the county of Crawfords a public highway.

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That from and after the passing of this act, the west branch of Oil creek from the upper forks thereof at M'Crat's now Winten's mill up to James Hamilton's mill in Bloomfield township, in the county of Crawford, shall be, and the same is hereby declared a public highway for the passage of rafts, boats and other vessels, and it shall and may be lawful for the inhabitants desirous of using or promoting the navigation of said creek, to remove all natural or artificial obstructions which may be in the same, excepting bridges, dams for mills and other water works, and also to erect such slopes at the mill dams now built or that may hereafter be built on said creek as may be necessary for the passage of rafts, boats and other vessels: Provided, Such slopes be so constructed as Proviso not to injure the work of said dams, or to alter the head or fall of said stream : And provided also, That any person or 2d proviso: persons owning or possessing lands on said creek shall have liberty to construct any dam or dams across the same agreeably and subject to all the restrictions and provisions of an act of the General Assembly of this commonwealth, passed the twenty-third day of March one thousand eight hundred and three, entitled "An act to authorise any person or persons owning land adjoining navigable streams of water de-
