Be it therefore enacted by the authority aforesaid, That the said William Tilghman shall be and is hereby authorised during the minority of his said grandson, to convey in fee simple, according to the terms of the several contracts made as aforesaid, either by the said James Allen in his life, or after his death by his widow Elizabeth Allen, deceased, or by the children of the said James and Elizabeth Allen, such lots within the aforesaid part of the said borough, as have been contracted for as aforesaid, to those purchasers, their heirs or assigns, who have already complied with or may hereafter comply with their contracts: *Provided,* That all conveyances to be made by the said William Tilghman by virtue of this act, shall be as valid and effectual as if his said grandson William Tilghman Chew was of full age and a party to the said conveyances, but shall have no greater validity or effect whatever; and that before any exercise of the powers conferred by this act, the said William Tilghman shall give bond with sureties, to the satisfaction of the orphans' court for the county of Philadelphia, for the faithful discharge of the duties herein required.

CHAPTER CXXIV.

AN ACT

Authorising the Governor of this Commonwealth to procure on loan, a certain sum therein mentioned.

Governor to
negotiate a
loan not ex-
ceeding
\$150,000.

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same,* That it shall be the duty of the Governor, and he is hereby authorised to negotiate a loan or loans, with any of the incorporated banks or other bodies politic, or individuals within this commonwealth, for such sum or sums, at an in-

terest not exceeding six per centum per annum, as may be necessary to meet the demands which may be made on the treasury within the present year, not exceeding in the whole the sum of one hundred and fifty thousand dollars, and the faith of this commonwealth is hereby pledged for the reimbursement of the said loan or loans within four years, and in such instalments as may be agreed on by the parties.

SECT. 2. *And be it further enacted by the authority aforesaid,* That the Governor be, and he is hereby directed to lay before the legislature within the first week of their next session, a report of his proceedings under this act. Report to be made to the legislature.

CHAPTER CXXV.

AN ACT

For laying out and opening a state road from Meadville to the west line of Pennsylvania, and for other purposes.

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same,* That George Long, John Work and James Cochran, Commissioners named. be, and they are appointed commissioners to do and perform the duties hereinafter enjoined on them, but previous to entering on the duties assigned them, they shall severally take an oath or affirmation before some judge or justice of the peace that they will do the duty imposed on them by this act with fidelity.

SECT. 2. *And be it further enacted by the authority aforesaid,* That the said commissioners shall between the first days of April and November next, proceed and lay out a road Time of laying out the road. fifty feet in width from Meadville in the county of Crawford, and leading thence through the town of Connaut at the outlet of the Connaut lake, to the west line of the state, in a direction to the town of Kinsman in the state of Ohio, to intersect Width and route.
