WHEREAS a port of entry is established by the United States at the town of Erie, in the state of Pennsylvania, for the harbor of Presque Isle, where it may be necessary for the collector of the port to seize and libel vessels sailing and trading to and from foreign ports and harbors. And whereas inconveniencies of great magnitude are experienced by the inhabitants residing in the western and northern parts of this state, living remote from the city of Philadelphia, by reason of being sued and impleaded in the circuit court of the United States in and for the district of Pennsylvania, and compelling their attendance at a very great distance, which the circumstances of many will not justify. And whereas it is just and right that the distribution of justice should be brought home to every man and administered without delay as nearly as the nature and circumstances of the government will admit.

Therefore.

RESOLVED by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, That the Senators from this state in the congress of the United States be instructed, and the members of the House of Representatives be requested, to use their endeavors to procure the passage of a law dividing the state of Pennsylvania into two districts, and establishing a district and circuit court of the United States at the city of Pittsburg, in the county of Allegheny.

Resolved, That the Governor direct the secretary to furnish an authenticated copy of the foregoing resolution to each of the senators and representatives of this state in the con-

gress of the United States.

And whereas numerous vessels have arrived in the past season, and more may arrive with German and other passengers. And whereas from the crowded state of many of those vessels, and from the want of an adequate

supply of provisions and medicine, as well as from other causes, many lives have been lost, and much privation endured by those unfortunate people. And whereas the legislature of Pennsylvania have passed two laws tending to secure the health, comfort and convenience, as well as for the protection generally of the before mentioned persons; the humane provisions of which may be in a great degree defeated unless regulations of the same, or of a similar import shall be adopted by the state of Delaware.

Be it therefore,

RESOLVED by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, That the Governor be, and he is hereby requested to transmit to the Governor of the state of Delaware, copies of the law for establishing a board of health for the port of Philadelphia, and the law relative to German and other passengers, with a request that he would lay the same before the legislature and invite their adoption of similar regulations.
