

the said Charles with the consent of the said James, surveyed and set off to a certain John Wilson his moiety of said land, and the said John now holds the same, but the said James having since died without executing any deed of partition or release of his title or interest therein, by reason whereof no patent can be issued to the said John Wilson, who therefore declines paying that part of the purchase money yet remaining due, and the executors of the said James Campbell have by their petition prayed to be authorised by law to release to the said John Wilson that part of the said tract surveyed and set off to him as aforesaid.

Therefore,

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same,* That James Campbell and M. Farland Campbell, executors of the last will and testament of James Campbell, late of Franklin county, deceased, be, and they are hereby authorised and empowered to execute and deliver to John Wilson, a deed of release for a tract of land in Franklin county, which was sold and conveyed to the said Wilson by Charles Campbell, which release shall be valid against all persons claiming under the said James Campbell, deceased.

CHAPTER XI.

AN ACT

To increase the number of constables in the township of Lower Dublin, in the county of Philadelphia.

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same,* That the electors of the township of Lower Dublin, in the county of Philadelphia, shall annually on the day ap-

pointed for the election of constables in the different townships in this commonwealth, hereafter elect four suitable persons inhabitants of the township aforesaid, two of which shall reside in the upper, and two in the lower district of said township. and return the names of the persons so elected to the next court of general quarter sessions of the peace to be held for the county of Philadelphia, two of whom shall be appointed constables for said township, one to reside in the upper and one in the lower district, in the same manner with like power and authority, and subject to the same regulations and penalties as are provided and contained in the several laws of this commonwealth relating to constables.

CHAPTER XII.

AN ACT

To provide for the more speedy publication and distribution of the laws of this commonwealth.

Duty of the Secretary of the Commonwealth.

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same,* That it shall be the duty of the Secretary of the Commonwealth, as soon as any law or laws is, or are deposited in his office, sufficient to form one octavo sheet, to prepare the same for the press, to affix thereto proper marginal notes, stating the purport of each paragraph or section, and to cause the same to be immediately printed in octavo form, and to collate with and correct the proof sheets by the original rolls, and immediately upon the printing thereof to cause to be delivered to the clerks of the Senate and House of Representatives four copies for the use of the Senate and ten copies for the use of the House of Representatives respectively.

SECT. 2. *And be it further enacted by the authority aforesaid,* That within one month after the close of each session
