CHAPTER LIX.

A SUPPLEMENT

BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That whenever the inhabitants of any of the townships, Town clerk, in any county within this commonwealth, authorised by the how appoinance to which this is a supplement, to elect and return to the ted, on a negcourt of quarter sessions, some fit person for a town clerk, one. shall neglect so to elect and make return, the court are hereby authorised to appoint some fit person for the office aforesaid, which person when appointed and notified thereof by the court, shall have and possess all power and authority, and His power perform the same duty that is vested in and enjoined on the and authority town clerk elected in manner prescribed by the act to which this is a supplement, and be subject to similar penalties for neglect of duty.

Sect 2. And if the owner shall not have appeared within sixty days after such advertisement and publication, the person taking up the same, shall make application to a justice of the peace, and the same proceedings shall be had as are directed by the act to which this is a supplement. And that so much of the act to which this is a supplement as is hereby altered, be, and the same is Repeal.
