CHAPTER XLI.

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That the jurisdiction of the mayor's court of the city of Lancaster be, and the same is hereby extended to all appeals courtextend- in civil cases from the judgments of justices of the peace and ed. aldermen of the city of Lancaster, be removed, heard, tried and determined in the same manner, and under the like provisions and restrictions as is provided by the laws of this Commonwealth for the case of appeals to the court of common pleas, from said justices and aldermen: Provided, That no alderman or justice of the peace shall be permitted to sit on the trial of any cause where the appeal is taken from his decision.

Secr. 2.
