## CHAPTER LXVII.

### *AN ACT*

Authorising William Scott, of Mercer county, guardian of the minor children of Benjamin Lodge, deceased, to convey certain lands therein mentioned.

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same,* That William Scott of Mercer county, guardian of the persons and estates of the minor children of Benjamin Lodge, deceased, he and he is hereby authorised and empowered, to execute a good and sufficient deed or deeds of conveyance, for the following tracts of land, situate on the waters of Shenango, in the county of Mercer, surveyed and returned on warrants issued under the act of the third of April, seventeen hundred and ninety-two, in the following names, viz. One in the name of Aaron Levi, one in the name of John Kapp, one in the name of Daniel Williams, one in the name of John Leacock, one in the name of Nathan Falkner, and one in the name of Daniel Reas, all patented to a certain James Hamilton, since deceased, (who is represented to have held the same only as the agent or trustee of the aforesaid Benjamin Lodge, also deceased,) in pursurance of the actual settlement and residence of sundry persons, with whom contracts had been made by the said James Hamilton, for the sale and settlement of the same, to the said settlers or their assignees, agreeably to their several contracts, in the same manner and for the same intents and purposes, as the said James Hamilton in his life time would or could by law have been obliged to do and perform in the premises: *Provided,* That nothing herein contained shall affect or impair the right or title of

any other person or persons in or to any part of the lands mentioned, or intended to be mentioned herein, but that the right and title of all such other persons shall remain of the same force and effect, as if this act had not been passed.

CHAPTER LXVIII.

*AN ACT*

Erecting part of Cumberland county, into a separate county to be called Perry.

Boundaries  
of Perry  
county.

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same,* That from and after the first day of September next all that part of Cumberland county lying north of the Blue mountain, beginning on the summit of the Blue mountain, where the Franklin county line crosses the same, and running thence along the summit thereof an eastwardly course to the river Susquehanna, thence up the west side of the same to the line of Mifflin county, thence along the Mifflin county line to the summit of the Tuscarora mountain, thence along the summit of the same to the Franklin county line, thence along the same to the place of beginning, be and the same is hereby declared to be erected into a separate county to be called Perry.

SECT. 2. *And be it further enacted by the authority aforesaid,* That the inhabitants of the said county of Perry from and after the first day of September next, shall be entitled to and at all times thereafter have, all and singular the courts, jurisdictions, offices, rights and privileges, to which the inhabitants of other counties of this state are entitled by the constitution and laws of this commonwealth.

SECT. 3. *And be it further enacted by the authority aforesaid,* That the several courts in and for the said county of Perry, shall be opened and held at such house in the town of Landisburg, as may be designated by the commissioners of said county, to be elected at the next general election, until a court house shall be erected in and for said county, as
