CHAPTER LXXXIII.

AN ACT

To exempt the volunteer corps of republican artillerists of Chester county, from training on the days now fixed by law, and for other purposes.

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That the volunteer corps of "Republican Artillerist," of Chester county, shall be, and are hereby exempted from training with the regiment or battalion to which they are attached, on the days of training fixed by law: and the said corps is hereby authorised to meet at any place within the division, at such times as shall be established by their bye-laws: Provided however, That the said corps shall meet as often as the militia are by law required to meet.*

SECT. 2. *And be it further enacted by the authority aforesaid, That the fines for non-attendance of the members of said corps on the aforesaid days of training, shall be collected as provided by the fourth section of a supplement to an act, for the regulation of the militia of this Commonwealth, passed the nineteenth day of March, one thousand eight hundred and sixteen, for the use of the said corps, and paid to*

the Quarter-master Sergeant thereof, and shall constitute a military fund, to be subject to the disposition of the company.

CHAPTER LXXXIV.

A SUPPLEMENT

To an act, entitled "An act, to provide for the erection of a State Penitentiary on the public land adjoining the town of Allegheny, opposite Pittsburg, in the county of Allegheny, and for other purposes."

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same,* That the commissioners appointed by the act to which this is a supplement, shall have power, and are hereby authorised, to contract for, acquire and purchase for the use of the Penitentiary adjoining the town of Allegheny, in the county of Allegheny, such water and water rights as they may think necessary and convenient to promote the health and cleanliness of the convicts and others confined within the said Penitentiary, and to lay and keep in repair such pipes and conduits, and to construct all such works as shall be deemed necessary to conduct the said water to, through, and from the said Penitentiary; and for this purpose shall have authority to sink and lay their pipes and conduits across and along any street, lane or public road, in such manner that when the work shall be completed there will be no obstruction to the passage of and travelling upon the same: And the said commissioners shall also have power and authority to contract for, acquire and purchase the right and privilege of laying and repairing pipes, and conducting the water aforesaid over and through the lands of any person or persons, where the same may be by them deemed necessary: And if any person or persons shall, after the purchase of the water or water rights as aforesaid, wilfully and maliciously obstruct the passage of the water to or from the said Penitentiary, or shall wilfully and maliciously injure or destroy any of the pipes, conduits or

Commissioners empowered to purchase certain water rights.
